AN ACT
CONFERRING UPON MEMBERS OF THE SANGGUNIANG BAYAN,
SANGGUNIANG PANLUNGSOD, AND SANGGUNIANG PANLALAWIGAN, THE
APPROPRIATE CIVIL SERVICE ELIGIBILITY UNDER CERTAIN
CIRCUMSTANCES, AND FOR OTHER PURPOSES

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1. Conferment of Civil Service Eligibility.** - An eligibility equivalent
2 to a Career Service Professional Eligibility is hereby conferred upon a member of the
3 *Sangguniang Bayan*, the *Sangguniang Panlungsod* and the *Sangguniang Panlalawigan*
4 who has served for an aggregate period of nine (9) years in office; *Provided*, That such
5 member must be a holder of a bachelor's degree.

6 A member who has served for an aggregate period of six (6) years shall be
7 granted an eligibility equivalent to a Career Service Sub-Professional Eligibility;
8 *Provided*, That such member shall have at least earned seventy-two (72) units in any
9 baccalaureate degree program.

11 **SEC. 2. Implementing Rules and Regulations.** - The Civil Service Commission
12 (CSC), in consultation with the Department of Interior and Local Government (DILG)
13 shall promulgate the necessary rules and regulations to implement this Act within ninety
14 (90) days after the effectivity of this Act.

1 **SEC. 3. Coverage** – This Act shall cover all members of the Sangguniang Bayan,
2 Sangguniang Panlungsod and Sangguniang Panlalawigan who have been elected after the
3 effectivity of the Local Government Code of 1991.

4
5 **SEC. 4. Repealing Clause**. - All laws, decrees, executive orders, rules and
6 regulations, issuances or any part thereof inconsistent with the provisions of this Act are
7 hereby repealed or amended accordingly.

8
9 **SEC. 5. Effectivity**. - This Act shall take effect fifteen (15) days following its
10 publication in the *Official Gazette* or in at least two (2) national newspapers of general
11 circulation.
