RESOLUTION ON SECOND READING P. S. Res. No. 1145--RP-Hungary Convention on the Avoidance of Double Taxation and Prevention of Fiscal Evasion With Respect to Taxes on Income

WHEREAS, the Convention provides for the means by which citizens of both countries could avoid double taxation and prevent fiscal evasion with respect to taxes on their respective incomes;

WHEREAS, the Convention shall apply, in case of the Philippines, to the income taxes imposed under Title II and the stock transaction tax in accordance with Section 127 of the Tax Reform Act of 1997; and in the case of Hungary, to income tax on individuals and corporation tax;

WHEREAS, the Convention also regards as taxes on income all taxes imposed on total income or on



3. Dividends, Interest and Royalties - The tax rates on these incomes are lower than the existing domestic tax rates of both countries, primarily to promote investment by the private sectors of the two states.

SPONSORSHIP SPEECH OF SENATOR OPLE

Senator Ople. Mr. President, on behalf of the Committee on Foreign Relations, I have the honor to submit for concurrence of the Senate the ratification of the Convention Between the Republic of the Philippines and the Republic of Hungary for the Avoidance of Double Taxation and the Prevention of Fiscal Evasion with Respect to Taxes on Income.

The first round of negotiations to conclude the Convention for the Avoidance of Double Taxation and the Prevention of Fiscal Evasion with Respect to Taxes on Income between the Republic of the Philippines and the Republic of Hungary was held in Budapest on April 27-29, 1992. The Philippine delegation was led by Mr. Jose Ong, then BIR Commissioner.

b. Interest - a rate of 15 percent.

However, interest is exempt from taxes in respect of:

i. A bond, debenture or other similar obligation of the government of the first mentioned Contracting State or a political subdivision or local authority thereof; or

ii. A loan made, refinanced, guaranteed or insured, or a credit extended, refinanced, guaranteed or insured by:

- in the case of the Philippines, the Central Bank of the Philippines;
- in the case of Hungary, the National Bank of Hungary, or


The second round of negotiations and the conclusion of the said convention transpired in Manila on February 19-23, 1996. The Philippine delegation was headed by BIR Commissioner Liwayway Vinzons-Chato. The Convention was signed on June 13, 1997 in Budapest by Ms Vinzons-Chato and Dr. Tibor Draskovics, Administrative Secretary of State, Ministry of Finance, representing the governments of the Philippines and Hungary, respectively.

The salient provisions embodied in the tax treaty include:

1) Personal scope - This provides for a reservation clause that both states are not precluded from taxing their citizens who may be residing in the other Contracting State in accordance with their domestic laws. However, in the case of the Philippines, this provision is no longer relevant because of the passage of the Tax Reform Act of 1997 which specifically provides that "a non-resident citizen is taxable only on income from sources within the Philippines."

- other governmental agencies or lending institutions as may be specified and agreed in an exchange of notes between the competent authorities of the Contracting States.
- Royalties—A rate of 15 percent, or the lowest rate of C. Philippine tax that may be imposed on royalties derived by a resident of a third state.
- Pensions-The provision on this Article conforms to d. our tax law that pensions arising from employment are not subject to tax.

Mr. President, in view of the foregoing, may I urge this august Chamber to concur in the ratification of the Convention Between the Republic of the Philippines and the Republic of Hungary for the Avoidance of Double Taxation and the Prevention of Fiscal Evasion with Respect to Taxes on Income.

Interpellations re Sen. Ople's Sponsorship Speech on P. S. Res. No. 1145

Senator Romulo. Mr. President.

The President. The Assistant Majority Leader, Senator Romulo, is recognized.

Senator Romulo. Mr. President, will the distinguished sponsor yield for a few questions?

Senator Romulo. Any additional income of the Hungarian citizen in Hungary or other countries outside of the Philippines is not subject to taxation by the Philippine government.

Senator Ople. Yes, that is correct, Mr. President.

Senator Romulo. On the question of fiscal evasion with respect to taxes on income, how would this apply to Filipino citizens?

Senator Ople. Very gladly to my distinguished colleague from Central Luzon, Senator Romulo.

Senator Romulo. Mr. President, this is a good Convention, and I am all for it. Basically, this Convention would address the problem of double taxation and the prevention of fiscal evasion with respect to taxes on income. Is that a fair statement?

Senator Ople. That is correct, Mr. President.

Senator Romulo. Mr. President, in avoiding double taxation, what rule would be applied? What tax would be imposed? What jurisdiction would be imposed?

Senator Ople. With respect to Filipinos in Hungary, they are already exempt from the payment of income tax under the CTRP law that has been enacted by Congress.

Senator Romulo. Under this Convention, can Hungary

Senator Ople. I suppose the general laws on tax evasion will apply in both Hungary and the Philippines to their respective nationals.

Senator Romulo. Is a Filipino who earns income in Hungary obliged to pay his income tax in the Philippines on that income earned in Hungary?

Senator Ople. No, Mr. President. He is exempt from the CTRP.

Senator Romulo. He is exempt.

Senator Ople. Yes, Mr. President.

Senator Romulo. Therefore, as far as the Filipino is concerned, he is exempt here and he will also be exempt from the income he earns in Hungary as far as the Philippine laws are concerned.

impose some tax on Filipinos who are exempt from the CTRP?

Senator Ople. Apparently not, Mr. President. The rule that prevails is where the income was earned. If it was earned in the Philippines, then obviously Hungary cannot impose any tax.

Senator Romulo. Under the CTRP, the Filipino citizen is exempt.

Senator Ople. Yes, Mr. President.

Senator Romulo. But since it was precisely earned in the Philippines and not in Hungary, then under this Convention the Hungarian government has no right to tax the Filipino citizen on the income of the Filipino citizen in the Philippines.

Senator Ople. It has no right under this treaty, Mr. President.

Senator Ople. Yes, Mr. President.

Senator Romulo. But he would be subject to the laws of Hungary if it imposes a tax on his income earned there?

Senator Ople. Yes, Mr. President.

Senator Romulo. Because this is a good law, Mr. President, how many countries has the Philippines entered into a convention? Would the gentleman have, at least, the ballpark figure?

Senator Ople. Yes, a total of 22 countries, Mr. President. I want to correct myself-it is 28 now, with the United States of America bringing up the rear.


Senator Romulo. Are Japan and the Asian countries included there?

Senator Romulo. How about the Hungarian citizens? Would that also apply? The Philippine government cannot tax the Hungarian citizen except the income of the Hungarian citizen in the Philippines. Is that correct?

Senator Ople. Yes, Mr. President.

Senator Ople. They are included, Mr. President.

Senator Romulo. Are the European countries also included there, Mr. President?

Senator Ople. Yes, the most important European countries.

Senator Romulo. Do I take it that because this is a good convention, there are pending conventions of similar nature with the other foreign countries where the Filipinos are working?

Senator Ople. Yes, I expect that there will be more agreements of this kind to be submitted to the Senate, Mr. President.

Committee on Foreign Relations can conclude the necessary public hearing, Mr. President.

Senator Romulo. I would like to thank the gentleman, Mr. President. I am in full support of this convention, and I would vote yes when this convention is called to a vote.

Thank you.

Senator Ople. May I thank the distinguished Assistant Majority Leader for that, Mr. President.

Senator Romulo. Would our distinguished sponsor be able to tell us how many such conventions are now pending in the Committee on Foreign Relations?

Senator Ople. There are seven such conventions pending before the Committee on Foreign Relations, Mr. President.

Senator Romulo. And what countries are involved here, Mr. President?

Senator Ople. May I enumerate: Bangladesh and Chile, with respect to international shipping; Finland; Hungary, which is now in the agenda; Indonesia, which is subject for renegotiation; Nigeria and Yugoslavia.

Senator Romulo. And so within the next two days left for the session, is there time to ratify these conventions?

Senator Tatad. Mr. President, there being no further interpellations, I move that the period of interpellations be closed.

The President. Is there any objection to this motion? [Silence] There being none, the motion is approved.

Senator Romulo. Would that mean that we should finally dispose of this resolution by tomorrow, Mr. President?

Senator Ople. Yes, Mr. President. I understand that the Department of Foreign Affairs has requested Malacañang for a certification.

Senator Romulo. On the other hand, Mr. President, as far as the others are concerned, perhaps, we can take them up between now and tomorrow and when we resume sessions after the elections, then those conventions can be passed.

Several Senators. Aye.

The President. As many as are against the resolution, say nay. [Silence]

Proposed Senate Resolution No. 1145 is approved on Second Reading.




