No. 32, recommending its approval in Substitution of S. No.s 3 and 104 on October 8, 1987; Submitted said report to the Senate on October 9, 1987; Assigned for consideration by Special Order on October 12, 1987;

Sponsorship speech by Senator Saguisag on October 13, 1987; Interpellations by Senators Laurel, Paterno, Lina, Jr., Shahani, Gonzales, Pimentel, Jr., Enrile, Romulo, Guingona, Jr. and Herrera on October 13, 1987; Period of amendments on October 14 and 15, 1987; Passed on Second Reading with amendments on October 15, 1987;

Passed on Third Reading on October 23, 1987; Sent to the House of Representatives requesting concurrence on October 23, 1987; Passed by the House of Representatives with amendments on June 9, 1988; Certified for immediate enactment by the President of the Philippines on June 9, 1988; House requested a conference on the disagreeing provisions and has designated Congressmen R. Dragon, C. R. Montejo, O. Orbos, J. Dureza, A. Escudero III on June 9, 1988; Senate agreed to the request and has designated Senators Saguisag, Tañada, Guingona, Jr., Enrile, and Shahani as its conferees at the same on June 9, 1988; Conference Committee recommended that S. No. 139 be approved with amendments, in consolidation with H. B. No. 12069; Conference Committee report agreed to by the Senate on October 21, 1988; Conference Committee report agreed to by the House on February 1, 1989; The Bill was presented to the President of the Philippines on February 13, 1989; Approved by the President of the Philippines on February 20, 1989;

REPUBLIC ACT NO. 6713.

NOTE: Senate Bill No. 139 was reported out by the House Committee on Civil Service (Ctte. Rpt. No. 114) recommending its approval with amendments on March 22, 1988, without any mention of H. No. 12069 because said bill was introduced and referred to said committee on a much later date - June 2, 1988. During the period of sponsorship on June 6, 1988 it was manifested that S. No. 139 be approved in substitution of H. No. 12069. S. No. 139 was approved on second reading with amendments on June 6, 1988. It was approved on third reading on June 9, 1988 and returned to the Senate on the same day. However, the Conference Committee in its Report recommended approval of Senate Bill No. 139 with amendments, consolidating therewith H. No. 12069.
