## **Explanatory Note**

This Bill seeks to amend Subsection (a) of Section 12-B of the Social Security Act of 1954, Republic Act No. 1161, as amended, so as to entitle SSS retirees to a five-year lump sum pension benefit.

Once this bill is passed into law, SSS retirees may invest in small businesses that will sustain them decently for the rest of their lives, something that they cannot do under the present law owing to the meager amounts provided under the straight monthly pension scheme.

The bill will likewise enable SSS retirees to enjoy similar benefits now granted to their counterparts in the GSIS as the latter have the option to convert the basic monthly pensions for the first five years into a lump sum. The scheme provided in the Revised GSIS Charter has proved beneficial, advantageous and fruitful to GSIS retirees.

The bill is based on the recommendation of the Sangguniang Panlunsod of Ormoc. It is a companion measure to H. No. 5014 filed by Rep. Danilo Suarez of the 3rd District of Quezon.

In view of the worthy objective of this bill, passage of the same is earnestly urged.

## AN ACT

GRANTING FIVE-YEAR LUMP SUM RETIREMENT BENEFITS TO S.S.S. RETIREES, AMENDING FURTHER FOR THAT PURPOSE SUBSECTION (a) OF SECTION 12-B OF THE SOCIAL SECURITY LAW, REPUBLIC ACT NO. 1161, AS AMENDED

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Subsection (a) of Section 12-B of the Social Security Law, Republic Act No. 1161, as amended, is hereby further amended to read as follows:

"SEC. 12-B. Retirement Benefits. (a) A covered employee who has paid at least one-hundred twenty monthly contribution; and who (1) has reached the age of sixty-five and is not receiving monthly compensation of at least three hundred pesos or (2) has reached the age of sixty-five years shall be entitled for as long as he lives to the monthly pension: PROVIDED, THAT, THE MEMBER SHALL HAVE THE OPTION TO CONVERT THE AMOUNT EQUIVALENT TO THE FIRST FIVE YEARS OF SAID RETIREMENT BENEFIT INTO A LUMPSUM: Provided, FURTHER, That his dependents born before his retirement of a marriage that was subsisting when he was fifty-seven years old shall be entitled to the dependent's pension."

SEC. 2. This Act shall take effect fifteen (15) days after its publication in a newspaper of general circulation.
