

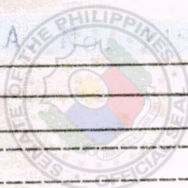

Read on FIRST READING and referred to the Committee
on Public Services on December 8, 1988;

Ctte. Rpt. No. 482 recommending its approval
without amendment on January 26, 1989;
Submitted said report to the Senate on January 27,
1989;

Assigned for consideration by Special Order on
January 30, 1991;

taking into consideration House Bill No. 32061 on
March 22, 1991;

Passed on Second Reading with amendments on May 9,

on May 17, 1991;

Senate requested the House of Representatives for a
conference on the disagreeing provisions of S. No.
901 and H. B. No. 32061, designating Senators
Osmeña, Paterno and Enrile as its conferees on
May 23, 1991;

House of Representatives agreed to the request of the Senate
for a conference, designating Congressmen Aquino (H),
del Mar, Tirador and Tirol as its conferees on
May 23, 1991;

Conference Committee recommended that H. B. No. 32061 in
consolidation with S. No. 901 be approved;

Conference Committee Report approved by the Senate on
June 6, 1991;

Conference Committee Report approved by the House of
Representatives on June 5, 1991;

Consolidated with H. No. 32061, which was approved and
signed by the President of the Philippines on September
12, 1991.
