Senate accepted the request of the House of Representatives for a conference ~~on the disagreeing provisions of S. No. 1333 and H. B. No. 10516~~, designating as its conferees Senators Pimentel, Jr., Lina, Jr. and Enrile on August 20, 1990;

Senators Alvarez and Angara were designated additional Members of the Conference Committee on the part of the Senate on October 24, 1990;

House of Representatives elected Congressmen Sarmiento, Sr., and Sator as additional members of the conference committee on the part of the House on February 5, 1991;

Conference Committee recommended that H. B. No. 10516 in consolidation with S. No. 1333 be approved;
