- Nov 4 - Read on first reading and referred to the Committee on Justice and Human Rights;

- Feb 7 - Returned by the Committee on Justice and Human Rights per Ctte Rpt No. 883, recommending its approval without amendment;
- 8 - Submitted said report to the Senate;
  - Sponsors: Senators Roco, Lina, Jr. and the members of the Ctte. on Justice and Human Rights;
  - Assigned for consideration by Special Order;
  - Sponsorship remarks of Senator Roco;
  - Cosponsorship remarks of Senator Lina, Jr.;
- 15 - Period of interpellations closed;
  - Period of committee amendments;
  - Period of committee amendments closed;
  - Period of individual amendments closed;
  - Passed on second reading with amendments;
  - Printed copies were distributed to the Senators;
  - Passed on third reading:
    - In favor: (16) Alvarez, Angara, Aquino, Coseteng, Gonzales, Herrera, Macapagal, Mercado, Osmena, Revilla, Roco, Romulo, Shahani, Sotto III, Tanada, and Webb;
    - Certified for immediate enactment by the President of the Philippines on February 14, 1995;
    - Senate requested the House of Representatives for a conference on the disagreeing provisions of SBN-1495 and HBN-10452, designating Senators Roco, ~~Guyot~~ and Tanada as its conferees;
    - Senators Lina, Jr. and Herrera were designated as additional members of the Senate's panel in the Bicameral Conference Committee on motion of Senator Romulo;
- 16 - Sent to the House of Representatives requesting for concurrence;
  - Conference Committee recommended that SBN-1495 and HBN-10452 as reconciled in the Conference Committee be approved;
- 20 - House of Representatives accepted the request of the Senate for a conference, designating Congressmen Garcia (P.), Apostol, Abueg, Jr., Abaya, and Damasing on February 15, 1995;
  - Sponsorship remarks of Senator Roco on the Bicameral Conference Committee;
  - Conference Committee Report approved by the Senate;
- 21 - Conference Committee Report approved by the House of Representatives on February 16, 1995;
