Sent to the House of Representatives, requesting concurrence on September 21, 1988;

House requests a conference on the disagreeing provisions of House Bill No. 4942 and has designated Congressmen Renato P. Dragon, Cirilo Roy G. Montejto, Estanislao V. Valdez, Benedicto G. Miran and Abdullah D. Dimaporo as its conferees on October 6, 1988;

Senate approved the appointment of Senators Rasul, Laurel, Guingona, Jr., Ziga and Enrile as members of the conference committee to meet with their counterparts in the House of Representatives on the disagreeing provisions of S. No. 373 and H. B. No. 4942 on October 10, 1988;

Conference Committee recommended that House Bill No. 4942 as amended, in consolidation with S. No. 373 be approved;
