AN ACT DEFINING AND PENALIZING THE CRIME OF PLUNDER.

Introduced by Senators Salonga, Saguisag, Romulo, Guingona, Jr., Mercado and Tanada on August 18, 1988;

Read on first reading and referred to the Committee on Constitutional Amendments, Revision of Codes and Laws on August 19, 1988;

Returned by the Committee on Constitutional Amendments, Revision of Codes and Laws per Ctte. Rpt. No. 451, recommending its approval with amendments on December 8, 1988;

Submitted said report to the Senate on December 12, 1988;
