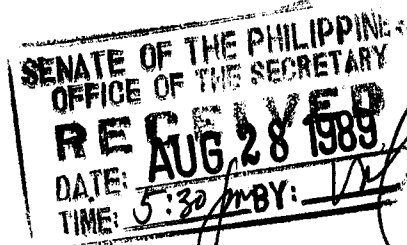

has considered the same and has the honor to report it back to the Senate with the recommendation that it be consolidated with Senate Bill No. 463 under Committee Report No. 196 in the light of the following background:

H. No. 23614 has been fully considered by this Committee and found the same substantially similar to Senate Bill No. 323 introduced by Senator Pimentel, Senate Bill No. 324 introduced by Senator Maceda, Senate Bill No. 330 introduced by Senator Pimentel and Senate Bill No. 816 introduced by Senator Gonzales which were all consolidated and reported out in the substitute Senate Bill No. 463 prepared by the Committee on National Defense and Security and the Committee on Local Government under Committee Report No. 196 submitted on May 5, 1988 with respect to S. Nos. 323, 324 and 330 and Committee Report No. 575 prepared by the Committee on National Defense and

Security and submitted on April 26, 1989 with respect to S. No. 816.
