The Senate Committees on Public Services and on Finance to which were referred H. B. No. 2095, introduced by Representatives Villarica, Sarmiento, Ungab, *et. al.* entitled:


**“AN ACT
CONVERTING THE LAND TRANSPORTATION OFFICE (LTO)
EXTENSION OFFICE LOCATED IN THE MUNICIPALITY OF STA.
MARIA, PROVINCE OF BULACAN INTO A REGULAR LTO DISTRICT

3. Still on the same page and line, delete the letter “s” in the word “newspapers”, and
4. Lastly, on the title. The new title shall read as follows,

LAND TRANSPORTATION OFFICE (LTO) LOCATED IN THE
MUNICIPALITY OF STA. MARIA, PROVINCE OF BULACAN
INTO A REGULAR LTO DISTRICT OFFICE AND





BY REPRESENTATIVES VILLARICA, SARMIENTO (C.), UNGAB AND PANCHO

AN ACT CONVERTING THE LAND TRANSPORTATION OFFICE (LTO) EXTENSION OFFICE LOCATED IN THE MUNICIPALITY OF STA. MARIA, PROVINCE OF BULACAN INTO A REGULAR LTO DISTRICT OFFICE, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The existing Land Transportation Office (LTO) Extension
2 Office located in the Municipality of Sta. Maria, Province of Bulacan is
3 hereby converted into a regular LTO District Office.

4 SEC. 2. The Secretary of Transportation and Communications shall
5 issue rules and regulations necessary for the effective implementation of this
6 Act.

7 SEC. 3. The Secretary of Transportation and Communications shall
8 immediately include in the Department's programs the operationalization of
9 the LTO District Office in the Municipality of Sta. Maria, Province of
10 Bulacan, the initial funding of which shall be charged against the current
11 year's appropriations of the Sta. Maria LTO Extension Office. Thereafter,
12 such sums as may be necessary for the continued operation of the LTO District
13 Office shall be included in the annual General Appropriations Act.

1 SEC. 4. All laws, rules and regulations inconsistent with the provisions
2 of this Act are hereby repealed or amended accordingly.

3 SEC. 5. This Act shall take effect fifteen (15) days following the
4 completion of its publication in the *Official Gazette* or in two (2) newspapers
5 of general circulation.
