**AN ACT CONVERTING THE KABACAN LAND TRANSPORTATION  
OFFICE (LTO) EXTENSION OFFICE IN THE MUNICIPALITY OF  
KABACAN, PROVINCE OF COTABATO INTO A REGULAR LTO  
DISTRICT OFFICE**

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The existing Kabacan Land Transportation Office (LTO)  
2 Extension Office is hereby converted into a regular LTO District Office. For  
3 this purpose, the Chief of the LTO, in consultation with the Secretary of the  
4 Department of Transportation and Communications, shall formulate the rules  
5 and regulations for the implementation of this Act.

6           SEC. 2. The Secretary of Transportation and Communications shall  
7 immediately include in the Department's programs the operationalization of  
8 the LTO District Office in the Municipality of Kabacan, Province of Cotabato,  
9 the initial funding of which shall be charged against the current year's  
10 appropriations of the Kabacan LTO Extension Office. Thereafter, such sums  
11 as may be necessary for the continued implementation of this Act shall be  
12 included in the annual General Appropriations Act.

13           SEC. 3. This Act shall take effect upon its approval.
