MR. PRESIDENT:

The Senate Committees on Public Services and on Finance to which were referred H. B. No. 216, introduced by Representatives Eriguel, Sarmiento and Ungab, entitled:


**"AN ACT
CONVERTING THE LAND TRANSPORTATION OFFICE
(LTO) EXTENSION OFFICE LOCATED IN THE
MUNICIPALITY OF AGOO, PROVINCE OF LA UNION INTO
A REGULAR LTO DISTRICT OFFICE AND
APPROPRIATING FUNDS THEREFOR."**

have considered the same and have the honor to report it back to the Senate with the recommendation that the attached H. B. No. 216 be approved with amendments, *to wit*:


1. On page 1, beginning line 4 up to line 6, delete the entire Section 2 and re-number the succeeding sections accordingly;
2. On the same page 1, line 8, after the conjunctive "of", delete the phrase "a regular LTO District Office in the Municipality of Agoo, province of La Union, the funding of which" and replace it with the phrase "THE LTO DISTRICT OFFICE IN AGOO, PROVINCE OF LA UNION, THE INITIAL FUNDING OF WHICH SHALL BE CHARGED AGAINST THE CURRENT YEAR'S APPROPRIATIONS OF THE EXTENSION OFFICE LOCATED IN AGOO, LA UNION. THEREFTER, SUCH SUMS AS MAYBE NECESSARY FOR THE CONTINUED OPERATION OF THE LTO DISTRICT OFFICE SHALL BE INCLUDED IN THE GENERAL APPROPRIATIONS ACT", and
3. Lastly, on the title. The new title shall read as follows,

**"AN ACT CONVERTING THE EXTENSION OFFICE OF THE
LAND TRANSPORTATION OFFICE (LTO) LOCATED IN THE
MUNICIPALITY OF AGOO, PROVINCE OF LA UNION INTO
A REGULAR LTO DISTRICT OFFICE AND APPROPRIATING
FUNDS THEREFOR."**





AN ACT CONVERTING THE LAND TRANSPORTATION OFFICE (LTO)
EXTENSION OFFICE LOCATED IN THE MUNICIPALITY OF
AGOO, PROVINCE OF LA UNION INTO A REGULAR LTO
DISTRICT OFFICE AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The existing Land Transportation Office (LTO) Extension
2 Office located in the Municipality of Agoo, Province of La Union is hereby
3 converted into a regular LTO District Office.

4 SEC. 2. The Secretary of Transportation and Communications shall
5 issue rules and regulations necessary for the effective implementation of this
6 Act.

7 SEC. 3. The Secretary of Transportation and Communications shall
8 immediately include in the Department's programs the operationalization of a
9 regular LTO District Office in the Municipality of Agoo, Province of La
10 Union, the funding of which shall be included in the annual General
11 Appropriations Act.

12 SEC. 4. This Act shall take effect fifteen (15) days after its publication
13 in the *Official Gazette* or in a newspaper of general circulation.
