2. Still on the same page and line, after the word “transportation” and before the word “office”, delete the word “extension”;
3. On the same page 1, line 6, after the letters “LTO” and before the word “office”, delete the word “extension” and replace it with the words “REGULAR DISTRICT”, and
4. Lastly, on the title, after the word “establishing”, and before the word “land”, insert the words “A REGULAR DISTRICT OFFICE OF THE”;
5. Still on the title, after the word “transportation”, delete the word “extension”.

AN ACT ESTABLISHING THE ORANI LAND TRANSPORTATION  
EXTENSION OFFICE IN THE MUNICIPALITY OF ORANI,  
PROVINCE OF BATAAN AND APPROPRIATING FUNDS  
THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. There shall be established, under the Department of  
2   Transportation and Communications, the Orani Land Transportation Extension  
3   Office in the Municipality of Orani, Province of Bataan.

4           SEC. 2. The Secretary of Transportation and Communications shall  
5   immediately include in the Department's programs the operationalization of  
6   the LTO extension office in the Municipality of Orani, Province of Bataan, the  
7   funding of which shall be included in the annual General Appropriations Act.

8           SEC. 3. This Act shall take effect fifteen (15) days after its publication  
9   in the *Official Gazette* or in a newspaper of general circulation.
