AN ACT INCREASING THE BED CAPACITY OF VICENTE SOTTO MEMORIAL MEDICAL CENTER LOCATED IN CEBU CITY, FROM EIGHT HUNDRED (800) TO ONE THOUSAND TWO HUNDRED (1,200) BEDS, AND APPROPRIATING FUNDS THEREFOR, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 8658, ENTITLED "AN ACT INCREASING THE BED CAPACITY OF VICENTE SOTTO MEMORIAL MEDICAL CENTER, LOCATED IN CEBU CITY, FROM FOUR HUNDRED (400) TO EIGHT HUNDRED (800) BED CAPACITY, AND APPROPRIATING FUNDS THEREFOR"

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. Section 1 of Republic Act No. 8658 is hereby amended to
2 read as follows:

3 "SECTION 1. The bed capacity of Vicente Sotto Memorial
4 Medical Center is hereby increased from [four hundred (400) to]
5 eight hundred (800) TO ONE THOUSAND TWO HUNDRED (1,200)
6 beds.

1 **“THE INCREASE IN BED CAPACITY OF VICENTE SOTTO**
2 **MEMORIAL MEDICAL CENTER FROM EIGHT HUNDRED (800)**
3 **TO ONE THOUSAND TWO HUNDRED (1,200) BEDS SHALL BE**
4 **IMPLEMENTED FOR A PERIOD OF NOT MORE THAN FOUR (4)**
5 **YEARS FROM THE APPROVAL OF THIS ACT.”**

6 SEC. 2. Section 2 of the same Act is hereby amended to read as
7 follows:

8 “SEC. 2. [The amount necessary to carry out the provisions
9 of this Act shall be included in the General Appropriations Act of
10 the year following its enactment into law and thereafter.] **THE**
11 **SECRETARY OF HEALTH SHALL INCLUDE IN THE**
12 **DEPARTMENT'S PROGRAMS THE IMPLEMENTATION OF THIS**
13 **ACT, THE FUNDING OF WHICH SHALL BE INCLUDED IN THE**
14 **ANNUAL GENERAL APPROPRIATIONS ACT.”**

15 SEC. 3. This Act shall take effect fifteen (15) days after its publication
16 in the *Official Gazette* or in a newspaper of general circulation.
