AN ACT DIVIDING BARANGAY MANGAGOY IN THE CITY OF
BISLIG, PROVINCE OF SURIGAO DEL SUR INTO EIGHT (8)
DISTINCT AND INDEPENDENT BARANGAYS TO BE KNOWN
AS BARANGAYS 1, 2, 3, 4, 5, 6, 7, AND 8

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Division of Barangay Mangagoy.* – Barangay Mangagoy
2 in the City of Bislig, Province of Surigao del Sur is hereby divided into eight
3 (8) distinct and independent barangays to be known as Barangays 1, 2, 3, 4, 5,
4 6, 7, and 8.

5 SEC. 2. *Territorial Boundaries.* – The territorial boundaries of each
6 barangay herein created shall consist of permanent natural boundaries
7 identified as existing puroks and sitios as follows:

- 8 (a) Barangay 1 shall consist of Barangay Mangagoy Proper, St. Paul,
9 Union Site and Central;
- 10 (b) Barangay 2 shall consist of Bongaitan and Market Site;
- 11 (c) Barangay 3 shall consist of Caramcam;
- 12 (d) Barangay 4 shall consist of Riverside, Bogac;
- 13 (e) Barangay 5 shall consist of John Bosco;
- 14 (f) Barangay 6 shall consist of Panaghiusa;
- 15 (g) Barangay 7 shall consist of Castillo Village; and

1 (h) Barangay 8 shall consist of Gamaon, Manggawong.

2 SEC. 3. *Conduct and Supervision of Plebiscite.* – Pursuant to Section
3 10 of Republic Act No. 7160, as amended, otherwise known as the “Local
4 Government of 1991”, the new barangays herein created shall exist upon the
5 majority of the votes cast by the qualified voters in a plebiscite to be conducted
6 and supervised by the Commission on Elections (COMELEC) in the entire
7 Barangay Mangagoy within one hundred twenty (120) days from the effectivity
8 of this Act.

9 The expenses for such plebiscite shall be borne by the City of Bislig,
10 Province of Surigao del Sur.

11 SEC. 4. *Incumbent Barangay Officials.* – The incumbent barangay
12 officials of Barangay Mangagoy, City of Bislig, Province of Surigao del Sur
13 shall continue to hold office until such time that their successors have been
14 duly elected and qualified.

15 SEC. 5. *Public Infrastructures and Facilities.* – All existing public
16 infrastructures and facilities for public use existing therein at the time of the
17 approval of this Act are hereby transferred without cost or compensation to and
18 shall be administered by the new barangays.

19 SEC. 6. *Internal Revenue Allotment Shares.* – All barangays herein
20 created namely: Barangays 1, 2, 3, 4, 5, 6, 7, and 8 shall be entitled to Internal
21 Revenue Allotment (IRA) shares pursuant to Section 285 of Republic Act
22 No. 7160, as amended, otherwise known as the “Local Government Code of
23 1991”.

24 SEC. 7. *Separability Clause.* – If, for any reason, any part or provision
25 of this Act is declared unconstitutional or invalid, the other parts or provisions
26 hereof which are not affected thereby shall continue to be in full force and
27 effect.

1 SEC. 8. *Effectivity.* – This Act shall take effect fifteen (15) days after
2 its publication in the *Official Gazette* or in any newspaper of general
3 circulation.
