

AN ACT CONVERTING THE GOA, CAMARINES SUR EXTENSION OFFICE OF THE LAND TRANSPORTATION OFFICE (LTO) INTO A REGULAR LTO CLASS "D" DISTRICT OFFICE TO BE LOCATED IN THE MUNICIPALITY OF TIGAON, PROVINCE OF CAMARINES SUR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The existing Goa, Camarines Sur Extension Office of the
2 Land Transportation Office (LTO) is hereby converted into a regular LTO
3 Class "D" District Office to be located in the Municipality of Tigaon, Province
4 of Camarines Sur.

5 SEC. 2. The Chief of the LTO, in consultation with the Secretary of the
6 Department of Transportation and Communications (DOTC), shall formulate
7 the necessary rules and regulations to implement this Act.

8 SEC. 3. The Secretary of the DOTC shall include in the Department's
9 programs the operationalization of the LTO Class "D" District Office in the
10 Municipality of Tigaon, Province of Camarines Sur, the initial funding of
11 which shall be charged against the current year's appropriation of the Goa,

1 Camarines Sur LTO Extension Office. Thereafter, such sums as may be
2 necessary for the continued implementation of this Act shall be included in the
3 annual General Appropriations Act.

4 SEC. 4. This Act shall take effect fifteen (15) days after its publication
5 in the *Official Gazette* or in any newspaper of general circulation.
