AN ACT SEPARATING THE TARUSAN NATIONAL HIGH SCHOOL  
- MALIHUD EXTENSION IN BARANGAY MALIHUD,  
MUNICIPALITY OF BATARAZA, PROVINCE OF PALAWAN  
FROM THE TARUSAN NATIONAL HIGH SCHOOL,  
CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH  
SCHOOL TO BE KNOWN AS MALIHUD NATIONAL HIGH  
SCHOOL AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The Tarusan National High School - Malihud Extension  
2 in Barangay Malihud, Municipality of Bataraza, Province of Palawan is hereby  
3 separated from the Tarusan National High School and converted into an  
4 independent national high school to be known as Malihud National High  
5 School.

6           SEC. 2. All personnel, assets, liabilities and records of the Tarusan  
7 National High School - Malihud Extension are hereby transferred to and  
8 absorbed by the Malihud National High School.

1           SEC. 3. The Secretary of Education shall immediately include in the  
2 Department's program the operationalization of the Malihud National High  
3 School, the initial funding of which shall be charged against the current year's  
4 appropriation of the Tarusan National High School – Malihud Extension.  
5 Thereafter, the amount necessary for the continued operation of the school  
6 shall be included in the annual General Appropriations Act.

7           SEC. 4. The Secretary of Education shall issue rules and regulations  
8 necessary to carry out the purpose of this Act.

9           SEC. 5. This Act shall take effect fifteen (15) days after its publication  
10 in the *Official Gazette* or in a newspaper of general circulation.
