AN ACT SEPARATING THE ATOK NATIONAL HIGH SCHOOL – ANNEX IN BARANGAY CAMP 30, CALIKING, MUNICIPALITY OF ATOK, PROVINCE OF BENGUET FROM THE ATOK NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS CAMP 30 NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. The Atok National High School – Annex in Barangay
2 Camp 30, Caliking, Municipality of Atok, Province of Benguet is hereby
3 separated from the Atok National High School and converted into an
4 independent national high school to be known as Camp 30 National High
5 School.
- 6 SEC. 2. All personnel, assets, liabilities and records of the Atok
7 National High School – Annex are hereby transferred to and absorbed by the
8 Camp 30 National High School.
- 9 SEC. 3. The Secretary of Education shall immediately include in the
10 Department's program the operationalization of the Camp 30 National High

1 School, the initial funding of which shall be charged against the current year's
2 appropriation of the Atok National High School - Annex. Thereafter, the
3 amount necessary for the continued operation of the school shall be included in
4 the annual General Appropriations Act.

5 SEC. 4. The Secretary of Education shall issue rules and regulations
6 necessary to carry out the purpose of this Act.

7 SEC. 5. This Act shall take effect fifteen (15) days after its publication
8 in the *Official Gazette* or in a newspaper of general circulation.
