





AN ACT CONVERTING THE VILLAFUERTE-PEÑA HIGH SCHOOL IN BARANGAY PONGLON, MUNICIPALITY OF SAN JOSE, PROVINCE OF CAMARINES SUR INTO A NATIONAL TECHNICAL-VOCATIONAL HIGH SCHOOL TO BE KNOWN AS JUAN C. PEÑA NATIONAL TECHNICAL-VOCATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR

Be It enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. *Conversion into a National Technical-Vocational High*
2 *School.* — The Villafuerte-Peña High School in Barangay Ponglon,
3 Municipality of San Jose, Province of Camarines Sur is hereby converted into
4 a national technical-vocational high school to be known as Juan C. Peña
5 National Technical-Vocational High School.

6 SEC. 2. *Transfer of Assets and Liabilities.* — All personnel, assets,
7 liabilities and records of the Villafuerte-Peña High School are hereby
8 transferred to and absorbed by the Juan C. Peña National
9 Technical-Vocational High School.

10 SEC. 3. *Appropriations.* — The Secretary of Education shall
11 immediately include in the Department's program the operationalization of the

1 Juan C. Peña National Technical-Vocational High School, the initial funding
2 of which shall be charged against the current year's appropriation of the
3 Villafuerte-Peña High School. Thereafter, the amount necessary for the
4 continued operation of the school shall be included in the annual General
5 Appropriations Act.

6 SEC. 4. *Implementation.* – The Secretary of Education shall issue the
7 rules and regulations necessary to carry out the purpose of this Act.

8 SEC. 5. *Effectivity.* – This Act shall take effect fifteen (15) days after
9 its publication in the *Official Gazette* or in a newspaper of general circulation.
