- AN ACT ESTABLISHING A BRANCH OF THE POLYTECHNIC OF UNIVERSITY THE PHILIPPINES IN THE MUNICIPALITY OF OF SABLAYAN. PROVINCE OCCIDENTAL MINDORO, TO BE KNOWN AS THE POLYTECHNIC UNIVERSITY OF THE PHILIPPINES (PUP)-SABLAYAN BRANCH, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. This Act shall be known as the "PUP-Sablayan
 Branch Act".

3 SEC. 2. There is hereby established a branch of the 4 Polytechnic University of the Philippines (PUP) in the Municipality 5 of Sablayan, Province of Occidental Mindoro, to be known as the 6 PUP-Sablayan Branch.

SEC. 3. The PUP-Sablayan Branch shall offer graduate,
undergraduate and short-term technical-vocational courses within
its areas of specialization and according to its capabilities, as the

Board of Regents (BOR) may deem necessary to carry out its
 objectives, particularly to meet the needs of the province and the
 MIMAROPA Region.

4 The PUP-Sablayan Branch is also mandated to undertake 5 research and extension services, and to provide progressive 6 leadership in these areas, including the offering of graduate degrees 7 under the PUP Open University System.

8 SEC. 4. The PUP-Sablayan Branch shall be headed by a 9 Branch Administrator who shall render full-time service and who 10 shall be appointed/designated by the BOR upon the 11 recommendation of the search committee and the President, subject 12 to the guidelines, qualifications and standards set by the BOR.

13 SEC. 5. The amount necessary to carry out the provisions of14 the Act shall be included in the annual General Appropriations Act.

SEC. 6. If, for any reason, any part or provision of this Act is
declared invalid or unconstitutional, the remaining parts or
provisions not affected thereby shall remain in full force and effect.

SEC. 7. All laws, presidential decrees, executive orders, rules
and regulations contrary to or inconsistent with the provisions of
this Act are hereby repealed or modified accordingly.

SEC. 8. This Act shall take effect fifteen (15) days after its
 publication in the *Official Gazette* or in a newspaper of general
 circulation.
