- AN ACT PENALIZING THE CONVERSION OR CAUSING THE CONVERSION OF IRRIGATED AND IRRIGABLE LANDS, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 6657, AS AMENDED, OTHERWISE KNOWN AS THE COMPREHENSIVE AGRARIAN REFORM LAW OF 1988
- Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:
- SECTION 1. Section 73 of Republic Act No. 6657, as amended, is hereby further amended to read as follows:
  - "Sec. 73. Prohibited Acts and Omissions. The following are prohibited:

5	"(J) THE ACTUAL PHYSICAL OR LEGAL
6	CONVERSION OR CAUSING THE PHYSICAL OR LEGAL
7	CONVERSION OF IRRIGATED AND IRRIGABLE LANDS BY:
8	"(1) ANY PERSON WHO DIRECTLY AND
9	INDIRECTLY PARTICIPATES IN THE CONVERSION OF
10	IRRIGATED AND IRRIGABLE LAND;
11	"(2) ANY PERSON WHO DIRECTLY OR
12	INDIRECTLY INDUCES THE LANDOWNER OR
13	FARMWORKER IN THE CONVERSION OF IRRIGATED AND
14	IRRIGABLE LAND;
15	"(3) ANY PERSON WHO APPLIES FOR AND
16	FACILITATES THE APPLICATION FOR CONVERSION;
17	"(4) ANY PERSON WHO FACILITATES THE
18	APPLICATION AND ISSUANCE OF CLEARANCES AND
19	OTHER DOCUMENTS NECESSARY FOR CONVERSION;
20	"(5) ANY PERSON WHO APPROVES AND CAUSE
21	FOR THE APPROVAL OF THE APPLICATION FOR
22	CONVERSION; AND
23	"(6) ANY PERSON WHO DIRECTLY AND
24	INDIRECTLY BENEFITTED FROM THE CONVERSION.
25	"FOR PURPOSES OF THIS SECTION, IRRIGATED
26	LANDS REFER TO LANDS SERVICED BY NATURAL
27	IRRIGATION OR IRRIGATION FACILITIES, AS
28	DELINEATED BY THE DEPARTMENT OF AGRICULTURE
29	OR THE NATIONAL IRRIGATION ADMINISTRATION,

1	WHICH INCLUDE LANDS WHERE WATER IS NOT READILY
2	AVAILABLE AS EXISTING IRRIGATION FACILITIES
3	NEED REHABILITATION OR UPGRADING, OR WHERE
4	IRRIGATION WATER IS NOT AVAILABLE YEAR-ROUND.
5	"IRRIGABLE LANDS REFER TO LANDS SUITABLE
6	FOR THE CONDUCT OF AGRICULTURAL ACTIVITIES
7	WHICH REQUIRE IRRIGATION AND DISPLAY PHYSICAL
8	FEATURES JUSTIFYING THE OPERATION OF AN
9	IRRIGATION SYSTEM, AND WHICH POSSESS AT LEAST
10	ONE OF THE FOLLOWING QUALITIES:
11	"(I) PHYSICAL FEATURES WHICH SHOW AN
12	INHERENT POTENTIAL FOR THE DEVELOPMENT OF AN
13	IRRIGATION SYSTEM, SUCH AS SOIL DEPTH, SOIL
14	TEXTURE, FIELD TERRAIN, SLOPE, AND OTHER
15	RELEVANT CHARACTERISTICS;
16	"(II) POTENTIAL FOR A QUALITY WATER SUPPLY
17	WHICH MAY BE SOURCED THROUGH A DISTRIBUTION
18	SYSTEM;
19	"(III) PART OF A SERVICEABLE AREA WHICH IS
20	WITHIN AN ACTUAL AND FUNDED IRRIGATION SYSTEM,
21	OR WHICH MAY BE SERVICED WITH EXISTING AND
22	OPERATING IRRIGATION FACILITIES;
23	"(IV) SITUATED WITHIN AN AREA WHERE THE
24	APPROVED OR ADOPTED LAND USE PLAN BY THE
25	CONCERNED LOCAL GOVERNMENT UNIT FOR
26	SURROUNDING OR CONTIGUOUS LANDHOLDINGS
27	WHICH ALLOWS THE CONDUCT OF AGRICULTURAL
28	ACTIVITIES; AND
29	"(V) PRESENCE OF AFFECTED QUALIFIED
30	FARMER-BENEFICIARIES, TENANTS OR LESSEES

1	WILLING TO TILL THE LAND AND RAISE CROPS
2	THEREIN; AND
3	"[(j)](K) Any other culpable neglect or willful
4	violations of the provisions of this Act.
5	"x x x."
6	SEC. 2. Section 74 of Republic Act No. 6657, as amended, is
7	hereby further amended to read as follows:
8	"SEC. 74. Penalties Any person who knowingly
9	or willfully violates the provisions of this Act shall be
10	punished by imprisonment of not less than one (1)
11	month to not more than three (3) years or a fine of not
12	less than One thousand pesos (P1,000.00) and not
13	more than Fifteen thousand pesos (P15,000.00), or
14	both, at the discretion of the court: Provided, That the
15	following corresponding penalties shall be imposed for
16	the specific violations hereunder:
17	"x x x
18	"(b) Imprisonment of six (6) years and one (1) day
19	to twelve (12) years or a fine of not less than Two
20	hundred thousand pesos (P200,000.00) and not more
21	than One million pesos (P1,000,000.00), or both, at the
22	discretion of the court upon any person who violates
23	Section 73, subparagraphs (c), (d), (e), [and] (i), AND
24	(J) of Republic Act No. 6657, as amended.
25	"x x x
26	"IF THE OFFENDER IS A PUBLIC OFFICER, THE
27	OFFENDER SHALL SUFFER THE ADDITIONAL
28	PENALTIES OF REMOVAL FROM OFFICE AND

1	PERPETUAL ABSOLUTE DISQUALIFICATION TO HOLD
2	PUBLIC OFFICE."
3	SEC. 3. All laws, acts, decrees, executive orders, issuances,
4	and rules and regulations or parts thereof which are contrary to and
5	inconsistent with this Act are hereby repealed, amended, or
5	modified accordingly.
7	SEC. 4. This Act shall take effect fifteen (15) days following its
3	publication in the Official Gazette or in any newspaper of general
)	circulation.
