AN ACT INCREASING THE BED CAPACITY OF VALENZUELA MEDICAL CENTER IN THE CITY OF VALENZUELA, FROM TWO HUNDRED (200) TO FIVE HUNDRED (500) BEDS, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. The bed capacity of Valenzuela Medical Center in the City of Valenzuela shall be increased from two hundred (200) to five hundred (500) beds. Said extension hospital shall be under the full administrative and technical supervision of the Department of

1	SEC. 2. The Secretary of Health shall immediately include in
2	the Department's programs the implementation of this Act, the
3	funding of which shall be included in the annual General
4	Appropriations Act.
5	SEC. 3. The increase in the bed capacity of the Valenzuela
6	Medical Center from two hundred (200) to five hundred (500) shall
7	be implemented for a period of not more than three (3) years from
8	the approval of this Act.
9	SEC. 4. Republic Act No. 7218, as amended, entitled, "An Act
10	Increasing the Bed Capacity of the Valenzuela District Hospital in
11	Valenzuela, Metro Manila, from Twenty-Five (25) to One Hundred
12	(100) Beds, and Appropriating Funds Therefor" and Republic Act
13	No. 9421, entitled, "An Act Upgrading the Valenzuela General
14	Hospital in the City of Valenzuela, Metro Manila Into a Two
15	Hundred Bed Capacity Tertiary Level Hospital to be Known as the
16	Valenzuela Medical Center and Appropriating Funds Therefor", are
17	hereby repealed.
18	SEC. 5. This Act shall take effect fifteen (15) days after its
19	publication in the Official Gazette or in any newspaper of general
