Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Creation of Barangay St. Francis II. - There is 1 hereby created a barangay in the Municipality of Limay, Province of 2 3 Bataan to be known as Barangay St. Francis II. SEC. 2. Territorial Boundaries. - The territorial boundaries 4 of Barangay St. Francis II are hereby described as follows: 5 "Bounded on the North by the Municipality of Orion 6 7 (Barangay Puting Buhangin); 8 On the South by Barangay San Francisco de Asis 9 (Creek, Mary Magdalene Memorial Park); 10 On the East by Manila Bay; and 11 On the West by Barangay Francisco de Asis (Bataan Expressway Road, Bliss)". 12 13 SEC. 3. Conduct and Supervision ofPlebiscite.

The plebiscite conducted and supervised by the Commission on

1	Elections (COMELEC) pursuant to Provincial Ordinance No. 11 of
2	the Sangguniang Panlalawigan of the Province of Bataan, which
3	ratified the creation of Barangay St. Francis II as proclaimed by the
4	Plebiscite Board of Canvassers, shall serve as substantial
5	compliance with the plebiscite requirement under Section 10 of
6	Republic Act No. 7160, otherwise known as the "Local Government
7	Code of 1991", as amended.
8	SEC. 4. Incumbent Barangay Officials The incumbent
9	barangay officials of Barangay St. Francis II shall continue to hold
10	office until such time that their successors have been duly elected
11	and qualified.
12	SEC. 5 Public Infrastructure and Facilities All public
13	infrastructure and facilities for public use existing therein at the
14	time of the approval of this Act are hereby transferred without cost
15	or compensation to and shall be administered by Barangay
16	St. Francis II.
17	Sec. 6 Internal Revenue Allotment Shares Barangay St.
18	Francis II shall be entitled to Internal Revenue Allotment (IRA)
19	shares pursuant to Section 285 of Republic Act No. 7160, otherwise
20	known as the "Local Government Code of 1991", as amended.
21	SEC. 7 Effectivity This Act shall take effect fifteen (15)
22	days after its publication in the Official Gazette or in a newspaper of
23	general circulation.
