AN ACT INCREASING THE RECRUITMENT QUOTA  
REQUIREMENT OF FEMALE PHILIPPINE NATIONAL  
POLICE (PNP) OFFICERS, AMENDING SECTION 58  
OF REPUBLIC ACT 8551, OTHERWISE KNOWN AS  
THE "PHILIPPINE NATIONAL POLICE REFORM AND  
REORGANIZATION ACT OF 1998"

*Be it enacted by the Senate and House of Representatives of the  
Philippines in Congress assembled:*

1 SECTION 1. Section 58 of Republic Act No. 8551, otherwise  
2 known as the "Philippine National Police Reform and  
3 Reorganization Act of 1998", is hereby amended to read as follows:

4 "SEC. 58. *Prioritization of Women for*  
5 *Recruitment.* - Within the next five (5) years, the PNP  
6 shall prioritize the recruitment and training of  
7 women who shall serve in the women's desk. Pursuant

1 to this requirement, the PNP shall reserve [ten]  
2 FIFTEEN percent [(10%)] (15%) of its annual  
3 recruitment, training, and education quota for  
4 women[.]: *PROVIDED, THAT THE RECRUITMENT QUOTA*  
5 *FOR WOMEN SHALL BE INCREASED TO TWENTY PERCENT*  
6 *(20%) THEREAFTER."*

7 SEC. 2. The National Police Commission, in coordination  
8 with the Philippine National Police and the Department of  
9 the Interior and Local Government, shall promulgate rules and  
10 regulations for the effective implementation of this Act. Such rules  
11 and regulations shall take effect upon their publication in two (2)  
12 newspapers of general circulation.

13 SEC. 3. All laws, presidential decrees, letters of instruction,  
14 executive orders, rules and regulations insofar as they are  
15 inconsistent with this Act, are hereby repealed or amended, as the  
16 case may be.

17 SEC. 4. This Act shall take effect fifteen (15) days after  
18 its publication in the *Official Gazette* or in a newspaper of  
19 general circulation.
