AN ACT INCREASING THE BED CAPACITY OF THE DR. SERAPIO B. MONTANER JR. MEMORIAL HOSPITAL IN THE MUNICIPALITY OF MALABANG, SECOND DISTRICT OF LANAO DEL SUR, FROM TWENTY-FIVE (25) BEDS TO SEVENTY-FIVE (75) BEDS, UPGRADING PROFESSIONAL HEALTH CARE ITS SERVICES AND FACILITIES. AUTHORIZING THE INCREASE OF COMPLEMENT ITS MEDICAL PERSONNEL APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The authorized bed capacity of the Dr. Serapio B. Montaner Jr. Memorial Hospital in Lanao del Sur is hereby increased from twenty-five (25) to seventy-five (75) beds.

SEC. 2. The existing professional health care services and facilities of the Dr. Serapio B. Montaner Jr. Memorial Hospital are hereby upgraded to conform and be commensurate to the increase in its authorized bed capacity as provided for in Section 1 hereof.

1	SEC. 3. The existing workforce of the Dr. Serapio B
2	Montaner Jr. Memorial Hospital shall be correspondingly increased
3	The Secretary of Health shall, in coordination with the Secretary of
4	Budget and Management and the Chairperson of the Civil Service
5	Commission, and after consultation with the management of the
6	Dr. Serapio B. Montaner Jr. Memorial Hospital, determine the
7	additional plantilla positions to be created and filled up.
8	SEC. 4. The increase in bed capacity of the Dr. Serapio B.

SEC. 4. The increase in bed capacity of the Dr. Serapio B. Montaner Jr. Memorial Hospital from twenty-five (25) to seventy-five (75) beds shall be implemented for a period of not more than two (2) years from the approval of this Act.

SEC. 5. The Provincial Government of Lanao del Sur shall provide the necessary funds for the maintenance and other operating expenses of the Dr. Serapio B. Montaner Jr. Memorial Hospital in the Municipality of Malabang. It shall also appropriate funds for human resource complement to support the increase in bed capacity and the corresponding upgrading of its service facilities and professional health care services. The Secretary of Health shall include in the Department's subsidy program, support for the capital outlays of the said hospital.

SEC. 6. Within sixty (60) days after the approval of this Act, the Secretary of Health shall issue the necessary rules and regulations for the effective implementation of this Act.

SEC. 7. This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a newspaper of general circulation.
