AN ACT RENAMING THE TALISAY DISTRICT HOSPITAL IN TALISAY CITY, PROVINCE OF CEBU, INTO CEBU SOUTH MEDICAL CENTER, AND APPROPRIATING FUNDS THEREFOR, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 7799, ENTITLED "AN ACT ESTABLISHING A DISTRICT HOSPITAL IN THE MUNICIPALITY OF TALISAY, PROVINCE OF CEBU, TO BE KNOWN AS THE TALISAY DISTRICT HOSPITAL, AND APPROPRIATING FUNDS THEREFOR"

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The Talisay District Hospital in Talisay City,
2 Province of Cebu, is hereby renamed as Cebu South Medical Center.

3 SEC. 2. The existing service capability, professional health
4 care services and medical staff complement of Cebu South Medical
5 Center is hereby upgraded and increased to correspond with the
6 requirements of the medical center.

1 SEC. 3. The increase in the service capability, health care
2 services and bed capacity shall conform to the hospital development
3 plan of the medical center.

4 SEC. 4. The Secretary of Health shall immediately include in
5 the Department's programs the implementation of this Act,
6 the funding of which shall be included in the annual General
7 Appropriations Act.

8 SEC. 5. Section 1 of Republic Act No. 7799, entitled "An Act
9 Establishing a District Hospital in the Municipality of Talisay,
10 Province of Cebu, to be Known as the Talisay District Hospital, and
11 Appropriating Funds Therefor" is hereby amended accordingly.

12 SEC. 6. Within ninety (90) days from the approval of this Act,
13 the Secretary of Health shall, in consultation with the Secretary of
14 Budget and Management, promulgate the necessary rules and
15 regulations for the effective implementation of this Act.

16 SEC. 7. This Act shall take effect fifteen (15) days after its
17 publication in the *Official Gazette* or in a newspaper of general
18 circulation.
