AN ACT SUBDIVIDING THE ONE-BARANGAY MUNICIPALITY OF DUMALNEG IN THE PROVINCE OF ILOCOS NORTE INTO THREE DISTINCT AND INDEPENDENT BARANGAYS TO BE KNOWN AS BARANGAY 1, BARANGAY 2 AND BARANGAY 3

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. *Subdivision of the One-Barangay Municipality of*
2 *Dumalneg.* – The One-Barangay Municipality of Dumalneg in the Province of
3 Ilocos Norte is hereby subdivided into three distinct and independent
4 barangays, namely: Barangay 1, Barangay 2 and Barangay 3.

5 SEC. 2. *Composition.* – The existing puroks and sitios shall comprise
6 the new barangays herein created, as follows:

7 A. Barangay 1 shall be composed of the following:

8 (1) Purok Cristalina

9 (2) Purok Saniata

- 1 (3) Sitio Pacac
- 2 (4) Sitio Banbanag
- 3 (5) Sitio Sta. Maria
- 4 (6) *Sitio Sisilungen*
- 5 (7) Sitio As-asaan
- 6 (8) Sitio Nasduan
- 7 (9) Sitio Nappud
- 8 (10) Sitio Nanguartao
- 9 (11) Sitio Siraong

10 B. Barangay 2 shall be composed of the following:

- 11 (1) Purok Timpuyog
- 12 (2) Poblacion
- 13 (3) Sitio Alilem
- 14 (4) Sitio Cabaritan
- 15 (5) Sitio Capcapitan
- 16 (6) Sitio Tapauan
- 17 (7) Sitio Immalsung
- 18 (8) *Sitio Mangadamay*

19 C. Barangay 3 shall be composed of the following:

- 20 (1) Purok Namnama
- 21 (2) Purok Danggayan

- 1 (3) Purok Regta
- 2 (4) Sitio Namoc
- 3 (5) Sitio Arapang
- 4 (6) Sitio Nalames
- 5 (7) Sitio Baracbac
- 6 (8) Sitio Bobog
- 7 (9) Sitio Baset

8 SEC. 3. *Seat of the Municipal Government.* – The seat of the municipal
9 government shall be at Poblacion, Barangay 2.

10 SEC. 4. *Conduct and Supervision of Plebiscite.* – Pursuant to Section
11 10 of Republic Act No. 7160, as amended, otherwise known as the Local
12 Government Code of 1991, the creation of the new barangays shall be ratified
13 by a majority of the votes cast by qualified voters of all the barangays herein
14 created in a plebiscite to be conducted and supervised by the Commission on
15 Elections, within sixty (60) days from the effectivity of this Act.

16 SEC. 5. *Barangay Officials.* – The first set of officials of the said
17 barangays shall be appointed by the provincial governor, in consultation with
18 the representative of the district, and shall hold office until such time that their
19 successors have been duly elected and qualified in the next regular barangay
20 election after the approval of this Act.

1 SEC. 6. *Internal Revenue Allotment Shares.* – The Municipality of
2 Dumalneg and all the barangays provided in Section 2 hereof shall be entitled
3 to Internal Revenue Allotment shares pursuant to Section 285 of Republic Act
4 No. 7160, otherwise known as the Local Government Code of 1991.

5 SEC. 7. *Appropriations.* – The amount necessary to conduct the
6 plebiscite as provided for under this Act shall be borne by the Municipality of
7 Dumalneg, Province of Ilocos Norte.

8 SEC. 8. *Effectivity.* – This Act shall take effect upon its approval.
