AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY
SAN MIGUEL IN THE CITY OF TAGUIG, METROPOLITAN
MANILA

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. *Creation of Barangay San Miguel.* – San Miguel
2 Proper in Barangay Hagonoy, City of Taguig, Metropolitan Manila
3 is hereby separated from Barangay Hagonoy and constituted into a
4 distinct and independent barangay to be known as Barangay San
5 Miguel.

6 SEC. 2. *Territorial Boundaries.* – The territorial boundaries
7 of Barangay San Miguel are hereby described as follows:

8 “Bounded on the North by Lot-5183 Psu-220212, Lot-5183
9 Psu-237646 Case 11 Mcadm 590-D Barangay of Bambang, Lot-5182,
10 5157 Case 11 590-D Mcadm 590-D Taguig Cadastral Mapping,
11 Lot-578 Case 2 Mcadm 590-D (Barangay Wawa), Rita Franco
12 Street, and Lot-386 Psu-241598 Case 2 Mcadm 590-D, M.L.Q.;

13 On the East and Southeast by Quezon Street, Lots-573, 572,
14 571, 570, 569, 568, all in Case 2 Mcadm 590-D (Barangay Wawa),
15 and an existing road dike;

1 On the South and Southeast by Lots-3949, 4174, 4175, 4177,
2 4228, 4229, 4379, 4337, 4336, 4339, 4229, 4342, 4344, 4345, 4347,
3 Mcadm 590-D Case 12 Taguig Cadastral Mapping, and a portion of
4 Lot-8640; and

5 On the West by Barangay Signal Village and NAPOCOR High
6 Tension Line.”

7 SEC. 3. *Conduct and Supervision of Plebiscite.* – The
8 plebiscite conducted and supervised by the Commission on Elections
9 (COMELEC) in Barangay Hagonoy pursuant to City Ordinance
10 No. 24, Series of 2008 of the Sangguniang Panlungsod of the City of
11 Taguig, which ratified the creation of Barangay San Miguel as
12 proclaimed by the City Board of Canvassers on December 28, 2008,
13 shall serve as substantial compliance with the plebiscite
14 requirement under Section 10 of Republic Act No. 7160, as
15 amended, otherwise known as the “Local Government Code of
16 1991”.

17 SEC. 4. *Incumbent Barangay Officials.* – The incumbent
18 barangay officials of Barangay San Miguel, City of Taguig shall
19 continue to hold office until such time that their successors have
20 been duly elected and qualified.

21 SEC. 5. *Public Infrastructure and Facilities.* – All public
22 infrastructure and facilities existing therein at the time of the
23 approval of this Act are hereby transferred without cost or
24 compensation to and shall be administered by the new barangay.

25 SEC. 6. *Internal Revenue Allotment Shares.* – Barangay San
26 Miguel shall be entitled to the Internal Revenue Allotment (IRA)
27 shares pursuant to Section 285 of the Local Government Code of
28 1991, as amended.

- 1 SEC. 7. *Effectivity.* – This Act shall take effect fifteen (15)
2 days after its publication in the *Official Gazette* or in a newspaper of
3 general circulation.
