AN ACT CREATING A BARANGAY TO BE KNOWN AS  
BARANGAY H-2 IN THE CITY OF DASMARIÑAS,  
PROVINCE OF CAVITE

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. *Creation of Barangay H-2.* – There is hereby  
2 created a barangay to be known as Barangay H-2 in the City of  
3 Dasmariñas, Province of Cavite.

4           SEC. 2. *Territorial Boundaries.* – The territorial boundaries  
5 of Barangay H-2 are hereby described as follows:

6 Description of Corners: Corners 1, 9, 28, 34 & 63 are BBM  
7 Nos. 131, 62, 132, 133 & 130, respectively, all, 20 x 20 x 100 cm.,  
8 corners 2 to 8 are centerline of  
9 Mangubat Avenue; corners 10 to 22 are  
10 centerline of Imus River; corners 23 & 24 are PS  
11 cyl. Conc. Monument; corners 25 to 33 are  
12 centerline of road; corners 36 to 62 are  
13 centerline of Pasong Baka Creek; and corners  
14 64-to 1 are centerline of road

15 SEC. 3. *Conduct and Supervision of Plebiscite.* – The  
16 plebiscite conducted and supervised by the Commission on Elections  
17 (COMELEC) pursuant to Provincial Ordinance No. 2000-004 of the  
18 Sangguniang Panlalawigan of Cavite, which ratified the creation of  
19 Barangay H-2 as proclaimed by the Plebiscite Board of Canvassers  
20 on 19 October 2003, shall serve as substantial compliance with the  
21 plebiscite requirement under Section 10 of Republic Act No. 7160,  
22 otherwise known as the “Local Government Code of 1991”, as  
23 amended.

24 SEC. 4. *Incumbent Barangay Officials.* – The incumbent  
25 elected barangay officials of Barangay H-2, City of Dasmariñas  
26 shall continue to hold office until such time that their successors  
27 have been duly elected and qualified.

28 SEC. 5. *Public Infrastructure and Facilities.* – All public  
29 infrastructure and facilities existing therein at the time of the

1 approval of this Act are hereby transferred without cost or  
2 compensation to and shall be administered by the new barangay.

3 SEC. 6. *Internal Revenue Allotment Shares.* – Barangay H-2  
4 shall be entitled to Internal Revenue Allotment (IRA) shares  
5 pursuant to Section 285 of the Local Government Code of 1991,  
6 as amended.

7 SEC. 7. *Effectivity.* – This Act shall take effect fifteen (15)  
8 days after its publication in the *Official Gazette* or in a newspaper of  
9 general circulation.
