AN ACT [~~RENAMING~~] UPGRADING THE TALISAY DISTRICT HOSPITAL IN TALISAY CITY, PROVINCE OF CEBU, INTO A MEDICAL CENTER TO BE KNOWN AS THE CEBU SOUTH MEDICAL CENTER, AND APPROPRIATING FUNDS THEREFOR, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 7799~~], ENTITLED "AN ACT ESTABLISHING A DISTRICT HOSPITAL IN THE MUNICIPALITY OF TALISAY, PROVINCE OF CEBU, TO BE KNOWN AS THE TALISAY DISTRICT HOSPITAL, AND APPROPRIATING FUNDS THEREFOR."~~

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The Talisay District Hospital in Talisay City,
2 Province of Cebu, is hereby UPGRADED INTO A MEDICAL
3 CENTER AND renamed as THE Cebu South Medical Center. THE
4 MEDICAL CENTER SHALL BE UNDER THE SUPERVISION AND
5 CONTROL OF THE DEPARTMENT OF HEALTH (DOH).

6 SEC. 2. The existing service capability, professional health
7 care services and medical staff complement of the Cebu South

1 Medical Center is hereby upgraded and increased to correspond
2 with the requirements of the medical center.

3 SEC. 3. The increase in the service capability, health care
4 services and bed capacity shall conform to the hospital development
5 plan of the medical center.

6 SEC. 4. THE CHIEF OF THE MEDICAL CENTER SHALL
7 DEVELOP A HOSPITAL DEVELOPMENT PLAN TO BE
8 SUBMITTED TO THE DOH TO REFLECT THE DEVELOPMENT
9 GOALS OF THE HOSPITAL, CONSISTENT WITH THE
10 INCREASE IN BED CAPACITY AND SERVICE CAPABILITY AS
11 PROVIDED IN SECTIONS 1 AND 2 HEREOF. REQUEST FOR
12 THE STAFFING REQUIREMENTS, CAPITAL OUTLAY
13 INVESTMENTS AND BUDGETARY NEEDS FOR OPERATIONS
14 SHALL BE BASED ON THE HOSPITAL DEVELOPMENT PLAN.

15 SEC. {4} 5. The Secretary of Health shall immediately include
16 in the Department's programs the implementation of this Act, the
17 funding of which shall be included in the General Appropriations
18 Act.

19 SEC. 6. IF ANY PROVISION OR PART OF THIS ACT IS
20 DECLARED UNCONSTITUTIONAL, THE REMAINING PARTS
21 OR PROVISIONS NOT AFFECTED SHALL REMAIN IN FULL
22 FORCE AND EFFECT.

23 SEC. [5] 7. [~~Section 1 of~~] Republic Act No. 7799, entitled "An
24 Act Establishing a District Hospital in the Municipality of Talisay,
25 Province of Cebu, to be known as the Talisay District Hospital, and
26 Appropriating Funds Therefor", is hereby amended accordingly.
27 ALL LAWS, EXECUTIVE ORDERS, ISSUANCES, RULES AND

1 REGULATIONS INCONSISTENT WITH THIS ACT ARE HEREBY
2 REPEALED OR MODIFIED ACCORDINGLY.

3 SEC. [6] 8. Within ninety (90) days from the approval of this
4 Act, the Secretary of Health shall, in consultation with the
5 Secretary of Budget and Management, promulgate the necessary
6 rules and regulations for the effective implementation of this Act.

7 SEC. [7] 9. This Act shall take effect fifteen (15) days after its
8 publication in the *Official Gazette* or in a newspaper of general
9 circulation.
