AN ACT

INCLUDING A NATIONAL ARTIST AS A MEMBER OF THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 7356, OTHERWISE KNOWN AS THE "LAW CREATING THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS"

*Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. Section 9 of Republic Act No. 7356, otherwise known as the "*Law*  
2 *Creating the National Commission for Culture and the Arts,*" is hereby amended by providing  
3 an additional subsection, to read as follows:

5           "Section 9. Composition. – The Commission shall be composed of the following members:

- 7           a) [the] Undersecretary of the Department of Education[, Culture and Sports];  
8           b) [the] Undersecretary of the Department of Tourism;  
9           c) [the] Chair[man]PERSON of the House Committee on BASIC EDUCATION AND  
10           Culture;  
11           d) [the] Chair[man]PERSON of the Senate Committee on EDUCATION, ARTS AND  
12           Culture;  
13           e) [the] President of the Cultural Center of the Philippines;  
14           f) [the Executive Director] CHAIRPERSON of the National Historical [Institute]  
15           COMMISSION OF THE PHILIPPINES;  
16           g) [the] Director GENERAL of the National Museum OF THE PHILIPPINES;  
17           h) [the] Director of the National Library OF THE PHILIPPINES;  
18           i) [the Director] CHAIRPERSON of the [Institute of Philippine Languages]  
19           KOMISYON SA WIKANG FILIPINO;  
20           j) [the] EXECUTIVE Director of the [Records Management and Archives Office]  
21           NATIONAL ARCHIVES OF THE PHILIPPINES;  
22           k) [the] Executive Director of the Commission;  
23           l) [the] Head of the Subcommittee on Cultural Communities and Traditional Arts;  
24           m) [t]Three (3) representatives from the private sector who shall be the elected heads of  
25           the THREE (3) SubcommitteeS identified hereunder, namely: the Subcommittee  
26           on Cultural Heritage, the Subcommittee on the Arts, and the Subcommittee on  
27           Cultural Dissemination. They shall be elected by the chairpersons of the national  
28           committee under their respective Subcommissions[.];

1 N) A REPRESENTATIVE FROM THE ORDER OF THE NATIONAL ARTISTS  
2 WHO SHALL BE ELECTED BY THE MEMBERS FROM AMONG  
3 THEMSELVES.  
4

5 The Chair[man]PERSON of the Commission shall be elected by the members from among  
6 themselves.”  
7

8 SEC. 2. This Act shall take effect fifteen (15) days after its publication in the *Official*  
9 *Gazette* or in a newspaper of general circulation.
