## "AN ACT

DECLARING THE HINAKPAN MYSTICAL HILLS IN THE CITY OF GUIHULNGAN, NEGROS ORIENTAL AS A PROTECTED AREA UNDER THE CATEGORY OF NATURAL MONUMENT UNDER THE NATIONAL INTEGRATED PROTECTED AREAS SYSTEM (NIPAS), AND PROVIDING FOR ITS MANAGEMENT"

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. Declaration of Policy. It is the policy of the State to
- 2 advance the right of the people to a balanced and healthful ecology. Towards this
- 3 end, the State shall ensure the protection and conservation of the biodiversity,
- 4 landscape, and the existing flora and fauna of the Hinakpan Mystical Hills, and to
- 5 promote its biological, and socio-cultural significance to the people of Negros
- 6 Oriental.
- 7 SEC. 2. Declaration as Protected Area. The Hinakpan Mystical Hills is
- 8 hereby declared a protected area under the category of natural monument pursuant
- 9 to Republic Act No. 7586, or "The National Integrated Protected Areas System
- 10 (NIPAS) Act", as amended by Republic Act No. 11038 or the "Expanded National
- 11 Integrated Protected Areas System Act of 2018".
- SEC. 3. Scope and Coverage. The boundaries of the Hinakpan Mystical
- 13 Hills Natural Monument are more particularly described as follows:

a. The Core Zone pertains to the area beginning at a point marked "1" on plan, which is S 85° 18' 25" W, 3,549.926 meters from PRS92 NGE-63 with geographic coordinates of 10°9'55.45478" Latitude and 123°13'0.07351" Longitude located at Barangay Villegas, Sitio Ampul, Guihulngan City, Province of Negros Oriental,

SEC. 4. Management and Institutional Mechanisms. - A Protected Area 20 Management Board (PAMB) is hereby created to provide overall management of the 21 area. A Protected Area Management Office (PAMO) shall be established and shall 22 be headed by a Protected Area Superintendent (PASu). The composition of the 23 PAMB, its powers and functions, as well as the duties and responsibilities of the 24 PASu, shall be in accordance with the provisions of Republic Act No. 7586, or the 25 National Integrated Protected Areas System (NIPAS) Act, as amended by Republic 26 Act No. 11038 or the "Expanded National Integrated Protected Areas System Act of · 27 2018". 28

SEC. 5. Implementing Rules and Regulations. – Within three (3) months from the effectivity of this Act, the Secretary of the DENR, in consultation with the

- local government units of the city of Guihulngan, the provincial government of Negros Oriental, and concerned national government agencies, shall issue the corresponding rules and regulations for the effective implementation of this Act.
  - SEC. 6. Appropriations. The Secretary of the DENR shall immediately include in the Department's Program the implementation of this Act, the funding of which shall be included in the annual General Appropriations Act.
  - SEC. 7. Separability Clause. If any provision of this Act is declared unconstitutional or invalid, other parts or provisions hereof not affected shall continue to be in full force and effect.
- SEC. 8. Repealing Clause. All laws, decrees, executive orders, rules and regulations or parts thereof which are contrary to or inconsistent with this Act are hereby repealed, amended or modified accordingly.
  - SEC. 9. Effectivity. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
