AN ACT

ESTABLISHING A CAMPUS OF THE UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES IN BARANGAY LUMBIA, CITY OF CAGAYAN DE ORO, PROVINCE OF MISAMIS ORIENTAL, TO BE KNOWN AS THE "UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES-LUMBIA CAMPUS", AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- **SECTION 1.** This Act shall be known as the "University of Science and Technology of Southern Philippines-Lumbia Campus Act".
- SEC. 2. There is hereby established a campus of the University of Science and Technology of Southern Philippines (USTSP) in Barangay Lumbia, City of Cagayan De Oro, Province of Misamis Oriental, which shall be known as the University of Science and Technology of Southern Philippines-Lumbia Campus.
- SEC. 3. The USTSP-Lumbia Campus shall primarily provide short-term, technical-vocational, undergraduate, and graduate courses within its areas of competency and specialization, as the Board of Regents, hereinafter referred to as the Board, may deem necessary for the accomplishment of its objectives, and those which respond to the human resource development needs of the Province of Misamis Oriental and Region X.

The USTSP-Lumbia Campus is also mandated to undertake research and extension services, and production activities in support of the socio-economic development and to provide progressive leadership in these areas.

- SEC. 4. The USTSP-Lumbia Campus shall be headed by a Campus Administrator who shall render full-time service and shall be appointed by the Board, subject to qualifications standards prescribed by the Board, and based on the recommendation of the search committee duly constituted for the purpose of selecting the Campus Administrator.
- SEC. 5. The USTSP-Lumbia Campus shall comply with the minimum requirements for its operation and program offerings, as prescribed by the Commission on Higher Education.
- SEC. 6. All liabilities and obligations shall be in the name of the USTSP and the personnel, records and assets, both real and personal, including all parcels of land belonging to the government to be occupied by the USTSP-Lumbia Campus shall be titled under the USTSP: *Provided*, That should the campus cease to exist or be abolished or should such aforementioned parcels of land be no longer needed by the USTSP, the same shall revert to the concerned local government unit or to the Republic of the Philippines, as the case may be.
- SEC. 7. The provisions of Republic Act No. 8292, otherwise known as the "Higher Education Modernization Act of 1997", shall form part of this Act.
- SEC. 8. The amount necessary for the effective implementation of this Act shall be included in the annual General Appropriations Act.
- SEC. 9. If, for any reason, any part or provision of this Act is declared invalid or unconstitutional, the remaining parts or provisions not affected shall remain in full force and effect.
- SEC. 10. All other laws, presidential decrees, executive orders, rules and regulations contrary to or inconsistent with the provisions of this Act are repealed or modified accordingly.
- SEC. 11. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
