AN ACT
PROVIDING FOR THE RANK CLASSIFICATION AND ORGANIZATION OF KEY POSITIONS IN THE BUREAU OF FIRE PROTECTION (BFP) AND BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP), AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 9263, OTHERWISE KNOWN AS THE "BUREAU OF FIRE PROTECTION AND BUREAU OF JAIL MANAGEMENT AND PENOLOGY PROFESSIONALIZATION ACT OF 2004", AS AMENDED BY REPUBLIC ACT NO. 9592, AND FOR OTHER PURPOSES

EXPLANATORY NOTE

This measure seeks to modify the rank classification of the personnel of the Bureau of Fire Protection (BFP) and the Bureau of Jail Management and Penology (BJMP). This is in consonance with the enactment of Republic Act No. 11200, otherwise known as *"An Act Providing for the Rank Classification in the Philippine National Police, Amending for the Purpose Section 28 of Republic Act No. 6975"*, as amended in June 2019.

This proposed measure aims to minimize confusion and enhance the public's understanding of the different bureaus. Furthermore, this bill seeks to enhance efficiency in inter-agency operations, in general.

In view of the foregoing, passage of this bill is earnestly sought.

AN ACT
PROVIDING FOR THE RANK CLASSIFICATION AND ORGANIZATION OF KEY POSITIONS IN THE BUREAU OF FIRE PROTECTION (BFP) AND BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP), AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 9263, OTHERWISE KNOWN AS THE "BUREAU OF FIRE PROTECTION AND BUREAU OF JAIL MANAGEMENT AND PENOLOGY PROFESSIONALIZATION ACT OF 2004", AS AMENDED BY REPUBLIC ACT NO. 9592, AND FOR OTHER PURPOSES

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 Section 1. Section 3 of Republic Act (RA) No. 9263, as amended, is hereby
2 amended to read as follows:

3 "Sec. 3. *Organization and Key Positions of the BFP and*
4 *the BJMP.* – The BFP and the BJMP shall be respectively
5 headed by a Chief who shall be assisted by two (2) Deputy
6 Chiefs, one (1) for Administration and one (1) for Operations,
7 all of whom shall be appointed by the President, upon
8 recommendation of the Secretary of the DILG from among
9 the qualified officers with at least the rank of [senior
10 superintendent] **FIRE/JAIL BRIGADIER GENERAL** in the
11 service: *Provided,* That in no case shall any officer who has
12 retired or is retirable within six (6) months from [his/her]
13 compulsory retirement age be appointed as Chief of the Fire
14 Bureau or Chief of the Jail Bureau, as the case may be:

1 *Provided, further,* That the Chief of the Fire Bureau and the
2 Chief of the Jail Bureau shall serve a tour of duty not to exceed
3 four (4) years: *Provided, however,* That in times of war or
4 other national emergency declared by Congress, the President
5 may extend such tour of duty.

6 “The heads of the BFP and the BJMP with the rank of
7 [~~director~~] **FIRE/JAIL GENERAL** shall have the position title
8 of Chief of the Fire Bureau and the Chief of the Jail Bureau,
9 respectively. The second officers in command of the BFP and
10 the BJMP with the rank of [~~chief-superintendent~~] **FIRE/JAIL**
11 **LIEUTENANT GENERAL** shall have the position title of
12 Deputy Chief for Administration of the Fire Bureau and Deputy
13 Chief for Administration of the Jail Bureau, respectively. The
14 third officers in command of the BFP and the BJMP with the
15 rank of [~~chief-superintendent~~] **FIRE/JAIL LIEUTENANT**
16 **GENERAL** shall have the position title of Deputy Chief for
17 Operation of the Fire Bureau and Deputy Chief for Operation
18 of the Jail Bureau, respectively. The fourth officers in
19 command of the BFP and the BJMP with the rank of [~~chief~~
20 ~~superintendent~~] **FIRE/JAIL LIEUTENANT GENERAL** shall
21 have the position title of Chief of Directorial Staff of the Fire
22 Bureau and Chief of Directorial Staff of the Jail Bureau, who
23 shall be assisted by the Directors of the Directorates in the
24 respective National Headquarters Office with at least the rank
25 of [~~senior-superintendent~~] **FIRE/JAIL MAJOR GENERAL**.

26 “The BFP and the BJMP shall **CONSTRUCT**, establish,
27 operate and maintain their respective regional offices in each
28 of the administrative regions of the country which shall be
29 respectively headed by a Regional Director for Fire Protection
30 and a Regional Director of Jail Management and Penology
31 with the rank of [~~senior-superintendent~~] **FIRE/JAIL**
32 **BRIGADIER GENERAL**[~~r~~], **WHO** [He/she] shall be

1 respectively assisted by the following officers with the rank of
2 [~~superintendent~~] **FIRE/JAIL COLONEL**: Assistant Regional
3 Director for Administration, Assistant Regional Director for
4 Operations, and Regional Chief of Directorial Staff:
5 **PROVIDED, THAT IN THE NATIONAL CAPITAL**
6 **REGION, THE AFOREMENTIONED OFFICERS SHALL**
7 **HAVE THE RANK OF FIRE/JAIL BRIGADIER GENERAL."**

8 Sec. 2. Section 5, paragraph (d) of RA 9263, as amended, is hereby amended
9 to read as follows:

10 "Sec. 5. *Appointment of Uniformed Personnel to the*
11 *BFP and the BJMP.* – The appointment of the BFP and the
12 BJMP shall be effected in the following manners:

13 "x x x

14 "(d) *Fire/Jail [~~Chief–Superintendent~~] BRIGADIER*
15 *GENERAL to Fire/Jail [~~Director~~] GENERAL.* – Appointed by
16 the President, upon recommendation of the Secretary of the
17 DILG, with the proper endorsement by the Chair[~~man~~] of the
18 Civil Service Commission (CSC).

19 "x x x."

20 Sec. 3. Section 7 of RA 9263, as amended, is hereby amended to read as
21 follows:

22 "Sec. 7. *Professionalization and Upgrading of*
23 *Qualification Standards in the Designation of Uniformed*
24 *Personnel of the BFP and the BJMP to Key Positions.* –

25 "a) No person shall be designated to the following key
26 positions in the BFP unless [~~he/she has met~~] the qualifications
27 provided therein **ARE MET**:

28 "1) *Municipal Fire Marshal.* – Should have the
29 rank of [~~senior–inspector~~] **FIRE LIEUTENANT**
30 **COLONEL**, who must have finished at least second
31 year Bachelor of Laws or earned at least twelve (12)
32 units in a Master's Degree Program in Public

1 Administration, Management, Engineering, Public
2 Safety, Criminology or other related disciplines from a
3 recognized institution of learning, and must have
4 satisfactorily passed the necessary training or career
5 courses for such position as may be established by the
6 Fire Bureau;

7 "2) *City Fire Marshal.* – Should have the rank of
8 [~~chief inspector~~] **FIRE COLONEL**, who must have
9 finished at least second year Bachelor of Laws or
10 earned at least twenty-four (24) units in a Master's
11 Degree Program in Public Administration,
12 Management, Engineering, Public Safety, Criminology
13 or other related disciplines from a recognized
14 institution of learning, and must have satisfactorily
15 passed the necessary training or career courses for
16 such position as may be established by the Fire Bureau;

17 [~~3) District Fire Marshal, Provincial Fire
18 Marshal, Assistant Regional Director for Administration,
19 Assistant Regional Director for Operations and
20 Regional Chief of Directorial Staff.~~ Should have the
21 rank of superintendent, who must be a graduate of
22 Bachelor of Laws or a holder of a Master's Degree in

2 from a recognized institution of learning, and must
3 have satisfactorily passed the necessary training or
4 career courses for such as may be established by the
5 Fire Bureau; and

6 "[6] **7) Chief of the Fire Bureau.** – Should have
7 the rank of [~~director~~] **FIRE GENERAL**, who must be a
8 member of the Philippine Bar or a holder of a Master's
9 Degree in Public Administration, Management,
10 Engineering, Public Safety, Criminology or other
11 related disciplines from a recognized institution of
12 learning, and must have satisfactorily passed the
13 necessary training or career courses for such position
14 as may be established by the Fire Bureau.

15 "No person shall be designated to the following
16 key positions of the BJMP unless [~~he/she has met~~] the
17 qualifications provided therein **ARE MET**:

18 "1) *Municipal Jail Warden.* – Should have the
19 rank of [~~chief-inspector~~] **JAIL LIEUTENANT**
20 **COLONEL**, who must have finished at least second
21 year Bachelor of Laws or earned at least twelve (12)
22 units in a Master's Degree Program in Management,
23 Public Administration, Public Safety, Criminology,
24 Penology, Sociology, National Security Administration,
25 Defense Studies, or other related disciplines from a
26 recognized institution of learning, and must have
27 satisfactorily passed the necessary training or career
28 courses for such position as may be established by the
29 Fire Bureau;

30 "2) *City Jail Warden.* – Should have the rank of
31 [~~chief-inspector~~] **JAIL COLONEL**, who must have
32 finished at least second year Bachelor of Laws or

1 earned at least twenty four (24) units in a Master's
2 Degree Program in Management, Public
3 Administration, Public Safety, Criminology, Penology,
4 Sociology, National Security Administration, Defense
5 Studies, or other related disciplines from a recognized
6 institution of learning, and must have satisfactorily
7 passed the necessary training or career courses for
8 such position as may be established by the Fire Bureau:
9 *Provided, That in City Jails with a population of one*
10 *thousand (1,000) or more inmates, the City Jail*
11 *Warden shall have the rank and qualification of a*
12 *District Jail Warden;*

13 "3) *District Jail Warden, Provincial Jail*
14 *Administrator, Assistant Regional Director for*
15 *Administration, Assistant Regional Director for*
16 *Operations and Regional Chief of Directorial Staff. –*
17 *Should have the rank of [senior-superintendent] **JAIL***
18 ***COLONEL**, who must be a graduate of Bachelor of*
19 *Laws or a holder of a Master's Degree in Management,*
20 *Public Administration, Public Safety, Criminology,*
21 *Penology, Sociology, National Security Administration,*
22 *Defense Studies, or other related disciplines from a*
23 *recognized institution of learning, and must have*
24 *satisfactorily passed the necessary training or career*
25 *courses for such position as may be established by the*
26 *Fire Bureau;*

27 "4) *Regional Director for Jail Management and*

30 Sec. 4. Section 12 of RA 9263, as amended, is hereby further amended to read
31 as follows:

1 "Sec. 12. **RANK CLASSIFICATION, Standardization**
 2 *of the Base Pay, Retirement and other Benefits of the*
 3 *Uniformed Personnel of the BFP and BJMP.* – In order to
 4 enhance the general welfare, commitment to service and
 5 professionalism of the uniformed personnel of the BFP and
 6 the BJMP, they shall receive the minimum starting salary
 7 equivalent to the salary grade level of the corresponding rank
 8 classification of their counterparts in the PNP, as provided
 9 under Section 36 of RA 8551, and in the AFP, as provided
 10 under Section 2 of RA 9166.

11 ~~"[The rate of the base pay of the uniformed personnel~~
 12 ~~of the BFP and the BJMP shall be adjusted in accordance with~~
 13 ~~the following salary grade schedule:]~~ **FOR PURPOSES OF**
 14 **EFFICIENT ADMINISTRATION, SUPERVISION AND**
 15 **CONTROL, THE RANK CLASSIFICATION AND THE**
 16 **CORRESPONDING RATE OF THE BASE PAY OF THE**
 17 **UNIFORMED PERSONNEL OF THE BFP AND BJMP**
 18 **SHALL BE AS FOLLOWS:**

3 "*Provided*, That all benefits currently received by the
4 uniformed personnel of the BFP and the BJMP under existing
5 laws shall continue to be received by them: *Provided, further*,
6 That their retirement pay shall be subject to the adjustment/s
7 based on the prevailing scale of base pay of the uniformed
8 personnel in the active service.

9 Sec. 5. *Implementing Rules and Regulations (IRR)*. – The DILG, in coordination
10 with the BFP and the BJMP, the CSC, the Department of Budget and Management
11 (DBM), and the Department of Finance (DOF), shall, within ninety (90) days from the
12 effectivity of this Act, promulgate the rules and regulations necessary to implement
13 the provisions of this Act.

14 Sec. 6. *Separability Clause*. – If any provision or part hereof is held invalid or
15 unconstitutional, the remainder of the law or the provision or part not otherwise
16 affected shall remain in full force and effect.

17 Sec. 7. *Repealing Clause*. – Any law, presidential decree or issuance, executive
18 order, letter of instruction, administrative order, rule, or regulation contrary to, or
19 inconsistent with, the provisions of this Act are hereby repealed, modified, or amended
20 accordingly.

21 Sec. 8. *Effectivity*. – This Act shall take effect fifteen (15) days after its
22 complete publication in the *Official Gazette* or in two (2) newspapers of general
23 circulation in the Philippines.
