AN ACT

CREATING A BARANGAY IN THE MUNICIPALITY OF ESPERANZA, PROVINCE OF SULTAN KUDARAT, TO BE KNOWN AS BARANGAY LEGODON

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1. *Creation of Barangay Legodon.*** – There is hereby created a barangay in the
2 Municipality of Esperanza, Province of Sultan Kudarat, to be known as Barangay Legodon.

3 **SEC. 2. *Territorial Boundaries.*** – The territorial boundaries of Barangay Legodon are
4 hereby described as follows:

5 “From Tran River as point one (1), following the agreed boundary
6 of Sitio Keping and Sitio Tropos going eastward up to Kaadakolan/Kabulnan
7 River known a point two (2). Going upstream of Kaadakolan/Kabulnan River
8 up to the political boundary of Municipality of Senator Ninoy Aquino and
9 Esperanza known as point three (3). Going westward following the political
10 boundary of Municipality of Senator Ninoy Aquino and Esperanza up to Tran
11 River known as point four (4). Going downstream of Tran River up to the
12 point of origin.”

13 **SEC. 3. *Conduct and Supervision of Plebiscite.*** – The plebiscite conducted and supervised
14 by the Commission on Elections pursuant to Provincial Ordinance No. 01-09 dated February 26,
15 2009, of the Sangguniang Panlalawigan of the Province of Sultan Kudarat, which ratified the
16 creation of Barangay Legodon as proclaimed by the Plebiscite Board of Canvassers on May 31,
17 2009 shall serve as substantial compliance with the plebiscite requirement under Section 10 of
18 the Local Government Code of 1991, as amended.

19 **SEC. 4. *Incumbent Barangay Officials.*** – The incumbent elected barangay officials of
20 Barangay Legodon shall continue to hold office until such time that their successors have been
21 duly elected and qualified.

1 **SEC. 5. *Public Infrastructure and Facilities.*** – All public infrastructure and facilities existing
2 therein at the time of the approval of this Act are hereby transferred without cost or
3 compensation to and shall be administered by the new Barangay Legodon.

4 **SEC. 6. *National Tax Allotment Shares.*** – Barangay Legodon shall be entitled to National
5 Tax Allotment shares pursuant to Section 285 of the Local Government Code of 1991, as
6 amended.

7 **SEC. 7. *Effectivity.*** – This Act shall take effect fifteen (15) days after its publication in the
8 *Official Gazette* or in a newspaper of general circulation.
