AN ACT
INCREASING THE NUMBER OF BOARD OF DIRECTORS OF
THE MACTAN-CEBU INTERNATIONAL AIRPORT
AUTHORITY, AMENDING FOR THE PURPOSE SECTION 6 OF
REPUBLIC ACT NO. 6958, OTHERWISE KNOWN AS THE
"CHARTER OF THE MACTAN-CEBU INTERNATIONAL
AIRPORT AUTHORITY"

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. Section 6 of Republic Act No. 6958, otherwise known as the
2 "Charter of the Mactan-Cebu International Airport Authority", is hereby
3 amended to read as follows:

5 "SEC. 6. *Board of Directors.* – The corporate powers of the
6 Authority shall be exercised by and vested in a Board of [eleven (11)]
7 **TWELVE (12)** members, which shall be composed of a [Chairman]
8 **CHAIRPERSON**, a Vice-[Chairman] **CHAIRPERSON** and [nine (9)]
9 **TEN (10)** members. The Secretary of Transportation [and
10 Communications] and the General Manager of the Authority shall be
11 the ex officio [Chairman] **CHAIRPERSON** and Vice-[Chairman]

1 CHAIRPERSON of the Board, respectively. The [Assistant
2 Secretary of the Air Transportation Office] **DIRECTOR GENERAL**
3 **OF THE CIVIL AVIATION AUTHORITY OF THE**
4 **PHILIPPINES (CAAP)** and the Secretaries of the following
5 executive departments or any Undersecretary or Assistant Secretary
6 designated by the respective Secretaries shall be ex officio members,
7 to wit: the Department of Finance, the Department of Justice, and the
8 Department of Tourism. In addition, four (4) members recommended
9 by the governor of the Province of Cebu shall be appointed by the
10 President of the Philippines for a term of [four (4)] **THREE (3)** years
11 from the private sector. The governor of the Province of Cebu or [his]
12 **THE** duly authorized representative shall be the ninth member. **THE**
13 **MAYOR OF THE CITY OF LAPU-LAPU OR THE DULY**
14 **AUTHORIZED REPRESENTATIVE SHALL BE THE TENTH**
15 **MEMBER.**

19 **SEC. 2.** All other laws, executive orders, letters of instruction, rules and
20 regulations, or parts thereof inconsistent herewith are hereby repealed or
21 amended accordingly.

23 **SEC. 3.** This Act shall take effect fifteen (15) days after its publication in
24 the *Official Gazette* or in a newspaper of general circulation.
