AN ACT AMENDING SECTION 27 OF REPUBLIC ACT NO. 7166, AS AMENDED BY REPUBLIC ACT NO. 8045, ENTITLED "AN ACT PROVIDING FOR SYNCHRONIZED NATIONAL AND LOCAL ELECTIONS AND FOR ELECTORAL REFORMS, AUTHORIZING APPROPRIATIONS THEREFOR, AND FOR OTHER PURPOSES"

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

i	SECTION 1. Section 27 of Republic Act No. 7166, as amended by
2	Republic Act No. 8045 is hereby further amended to read as follows:
3	"SEC. 27. Number of Copies of Election Returns and
4	their Distribution The board of election inspectors shall
5	prepare in handwriting the election returns in their respective
5	polling places, in the number of copies herein provided and
7	in the form to be prescribed and provided by the Commission.
3	"The copies of the election returns shall be distributed

as follows:
