EXPLANATION OF VOTE OF SENATOR ANGARA

Senator Angara. Mr. President, I vote in favor of this bill. I think it is a laudable bill. I vote primarily because I would like to see the day when the Philippines will have no more standing army and would be training people for civic welfare as well as social development. I believe that the ROTC program, while a very important source of officer corps in the military, maybe is not the best system for training our military officers.

Of course, we always say that the civilian dimension of the military is supplied more by the ROTC graduates than by the PMA graduates. But still after almost 60 years of a standing army, I believe that the Philippines should aspire to a status where there will be no more standing army and all the ablebodied men and women will be serving in the civilian field, especially in literacy, in health and in environment as envisioned by this bill.

I will submit a lengthier explanation, Mr. President, but in the meantime that would suffice for voting affirmatively for this measure.

The following is the written explanation of vote of Senator Angara:

The challenge of developing a sense of nationalism and civic consciousness among the modern day Filipino youth has become greater than ever before. At this time, we need to develop a citizenry who will be instrumental inpromoting civic welfare and social development. In the long run, our country will be needing more able-bodied

people who will be serving in their civilian capacity in the fields of literacy, health, environment and other civic welfare activities.

While there is a need to continuously strengthen our military corps, it is also necessary to broaden the present ROTC program as a vehicle not only in providing military training for our tertiary students, but more importantly to cater to the other socio-civic needs of our country in light of the changing times.

I would like to see the day when the Philippines will have no more standing army but a corps of young Filipinos who are trained to practice voluntarism and patriotism in the service of the nation.

In view of this, there is a need to expand the opportunities available to the youth to be involved in community service and development programs. In this regard, we have voted for the passage of the National Service Training Program Act of 2001.

The law has institutionalized a comprehensive training program which will enhance the youth's active contribution to general welfare. Through this law, we can encourage the youth to become more involved in community activities which are vital in nation-building.

I just want to put on record that in my three years in this Chamber, I have not seen a bill that has been debated, interpellated and given a lot of attention and support by practically all the members of this Chamber. And I wish to put on record our appreciation on behalf

of the Committee on Education, Arts and Culture as well as on behalf of my cochairman, Senator Magsaysay of the Committee on National Defense and Security for the tremendous support that has been given to this bill.

EXPLANATION OF VOTE OF SENATOR J. OSMEÑA

Senator J. Osmeña. Mr. President, I would just like to explain my vote very briefly.

I have supported this bill, and I am voting in favor of this bill. As a matter of fact, I have introduced a number of amendments for which I thank the sponsors for accepting them—the amendment on the suspension of ROTC requirements.

I have been told when I went to Cebu over the weekend that thousands of students have not been able to graduate because they have failed to comply with the ROTC requirements. I am glad that with this suspension, these young men and women who have completed their academic studies will finally graduate.

The other matter, Mr. President, which is the other amendment that we were able to introduce is the matter of scholarship; that it should be equitably distributed nationwide.

The education budget of this country is vastly distorted. Almost 75% of the money is spent in NCR. That is why I introduced this amendment so that the sad experience of education—for example, the UP budget until a few years ago was totally an NCR-concentrated budget. To this day, the distortion continues and persists notwithstanding the fact that, unfortunately, the Cebuano president of UP does not even see the light despite the fact that we have had three budget hearings and we have tried to hammer this fact into him. That is the other amendment that we introduced.

But more than these amendments, Mr. President, we are bringing to an end 50 years of waste—waste of time, waste of manhours, waste of resources.

During the interpellations, we were able to establish that at least P345 million a year is being wasted on the ROTC program. That is 50 years of P345 million. That is, shall we say, cause for celebration—bringing an end to this waste. Hence, my affirmative vote, Mr. President.

EXPLANATION OF VOTE OF SENATOR PANGILINAN

Senator Pangilinan. Mr. President, just a few words.

I vote in the affirmative and as the second youngest member of this Chamber, I vote in favor of the bill because it represents the clamor and sentiments of our young people.

I was a freshman in the University of the Philippines 20 years ago and the issues raised then about the relevance of the ROTC are still the issues raised today. I am amplifying the observations of Sen. John Osmeña that indeed, at least 20 years later from my time, the clamor and the question regarding the relevance of ROTC, sabi nga po nila, is like a broken record.

Finally, at least from my point of view, after 20 years when I was a freshman in the university, the issues and questions raised 20 years ago are finally, with this bill becoming law, being resolved. Two decades is too long a time for our young people to have a law that will make ROTC meaningful and the other service programs. So, I vote in the affirmative.
