OPENING OF THE SESSION

At 10:26 a.m., the Senate President, Hon. Aquilino Q. Pimentel Jr., called the session to order.

The President. The 53rd session of the Senate in the Third Regular Session of the Eleventh Congress is hereby called to order.

Let us all stand for the opening prayer to be led by Sen. Loren Legarda-Leviste. She is not yet in the hall. So let us have a one-minute... Ah, Senator Magsaysay will read the prayer on her behalf.

PRAYER

Senator Magsaysay. This is on behalf of Sen. Loren Legarda-Leviste, Mr. President.

APPROVAL OF S. NO. 2128 ON THIRD READING

The President. With 12 affirmative votes, no negative vote, and no abstention, Senate Bill No. 2128 is approved on Third Reading.

CONFERENCE COMMITTEE REPORT ON S. NO. 2216/H. NO. 499 (Art Authentication Act of 2000)

Senator Tatad. Mr. President, I move that we now consider the Bicameral Conference Committee Report on the disagreeing provisions of Senate Bill No. 2216 and House Bill No. 499.

The President. Is there any objection? [Silence] There being none, the motion is approved.

Senator Tatad. I ask that Sen. Teresa Aquino-Oreta be recognized to sponsor this report.

The President. Sen. Teresa Aquino-Oreta is recognized.

REPORT OF SENATOR AQUINO-ORETA

Senator Aquino-Oreta. Thankyou, Mr. President.

Mr. President, the Conference Committee on the disagreeing provisions of Senate Bill No. 2216 and House Bill No. 499, after having met and fully discussed the subject matter, would like to report the following:

- 1. Both the Senate and the House versions were adopted as working drafts,
- 2. Section 1 of both bills were merged and modified as Section 1 of the consolidated version, to read as follows:

SECTION 1. Short Title. - This Act shall be known as the "Art Forgery Act of 2001.";

- 3. Section 3 of the Senate version was rearranged to give emphasis to the definition of art forgery. Subsection (c), items, i, ii, iii and iv, which enumerate the acts of art forgery, were transposed to become the new subsection (a), items 1, 2, 3 and 4. Subsequently, subsections (a) and (b) became subsections (b) and (c), respectively;
- 4. The intent of the Senate bill to institutionalize the Panel of Experts, as prescribed by Republic Act No. 4846, as amended by Presidential Decree No. 374, and the proposal of the House bill (Section 5) to create an Art Authentication Board, were merged, modified and adopted as Section 4 of the consolidated version, to read as follows:

SEC. 4. ARTAUTHENTICATION PANEL; CREATION AND COMPOSITION. - THERE IS HEREBY CREATED A PANEL TO BE KNOWN AS THE ART AUTHENTICATION PANEL TO REPLACE AND ASSUME THE POWERS AND FUNCTIONS OF THE PANEL OF EXPERTS FOR FINE ARTS PROVIDED FOR INREPUBLIC ACT 4846, AS AMENDED BY P.D. 374. THE PANEL SHALL BE COMPOSED OF THREE (3) MEMBERS, WHO SHALL BE CHOSEN AND APPOINTED BY THE NATIONAL MUSEUM BOARD OF TRUSTEES FROM A LIST SUBMITTED BY THE SEARCH COMMITTEE CREATED UNDER SECTION 8 OF THIS ACT.

MOTION OF SENATOR PIMENTEL (Conference Committee Report Considered as Read into the Record)

The President. Maybe, Senator Aquino-Oreta can submit the report and we will consider it as read—

Senator Aquino-Oreta. All right.

The President. —so that she will not be losing her voice.

Senator Aquino-Oreta. All right, if no one will object to it.

The President. Is there any objection? [Silence] There being none, the motion is approved.

The Majority Leader is recognized.

APPROVAL OF CONFERENCE COMMITTEE REPORT ON S. NO. 2216/H. NO. 499

Senator Tatad. I move that we the adopt the report.

The President. And consider the rest of the report as read into the *Record*.

Is there any objection? [Silence] There being none, the motion is approved.

Senator Aquino-Oreta. Thankyou, Mr. President.

The following is the whole text of the continuation of the conference committee report:

- 5. Section 6 of the Senate version (Broadening of the Powers of the Panel) was amended and adopted as Section 5 of the consolidated version. The title and the first paragraph of the Section were revised to conform to the new Section 4, to read:
- "SEC. 5. FUNCTIONS OF THE ART AUTHEN-TICATION PANEL. - IN ADDITION TO THE POWERS GRANTED TO IT UNDER REPUBLIC ACT 4846 AS AMENDED, THE ART AUTHENTICATION PANEL, HEREIN REFERRED TO AS THE PANEL, SHALL ALSO HAVE THE FOLLOWING POWERS AND FUNCTIONS:"
- 6. Section 7 of the Senate version (Qualifications of the Members of the Panel) was adopted as the new Section 6, with the following amendments:
- a. On the title, after the word "Panel", the phrase "of Experts." was deleted;
- b. On the text, the word "reputed" was replaced with the word "PROVEN."; and the provisos were deleted and made part of the new Section 7.

Thus, the new Section 6 shall read as follows:

"SEC. 6. QUALIFICATIONS OF THE MEMBERS OF THE PANEL. - THE MEMBERS OF THE PANEL MUST BE CITIZENS OF THE PHILIPPINES, AT LEAST THIRTY-FIVE (35) YEARS OF AGE ON THE DAY OF THEIR APPOINTMENT, OF PROVEN COMPETENCE, INTEGRITY, PROBITY AND INDEPENDENCE OF MIND, AND HOLDERS OF A DEGREE OR EQUIVALENT TRAINING AND EXPERIENCE IN ART CONSERVATION, CONNOISSEURSHIP, ART HISTORY, OR VISUAL ARTS."

7. Section 7 of the House version, the provisos of Section 7 and item a., Section 5 of the Senate version, were merged, modified and adopted as Section 7 of the consolidated version, to wit:

"SEC. 7. TERMOFOFFICE.-THE MEMBERS OF THE PANEL SHALL BE APPOINTED BY THE BOARD OF TRUSTEES FOR A TERM OF TWO (2) YEARS: PROVIDED, THAT NO MEMBER OF THE PANEL SHALL SERVE FOR MORE THAN TWO (2) CONSECUTIVE TERMS: PROVIDED, FURTHER, THAT APPOINTMENT TO ANY VACANCY SHALL ONLY BE FOR THE UNEXPIRED TERM OF THE PREDECESSOR AND SHALL BE COUNTED AS ONE TERM."

- 8. Section 4 of the Senate version (*Creation of a Search Committee for the Panel*) was adopted as the new Section 8 of this proposed Act but with the following amendments:
- a. On the title, the phrase "of Experts" after the word "Panel" was deleted;

and

- b. The phrase ",BUTNOTLIMITED TO," between the phrases "composed of" and "the following persons." was inserted;
- 9. Section 5 of the Senate version (Functions of the Search Committee for the Panel) was adopted as the new Section 9, with certain modifications of subsection a. which shall now read, as follows:
- "a. SUBMIT TO THE NATIONAL MUSEUM BOARD OF TRUSTEES A LIST OF SIX (6) NAMES, FROM WHICH THE MEMBERS OF THE PANEL SHALLBE CHOSEN; AND";
 - 10. Section 7, second paragraph of the Senate

version was refined and made Section 10 of the consolidated version, which shall read as follows:

"SEC. 10. COMPENSATION.-MEMBERS OF THE SEARCH COMMITTEE, THE PANEL AND THE ART CONSULTANTS SHALLBE ENTITLED TO RECEIVE PER DIEMS IN ACCORDANCE WITH EXISTING RULES AND REGULATIONS.";

- 11. Section 9 of the Senate version was amended and adopted as the new Section 11. The phrase "Five thousand pesos (P5,000.00)" was deleted and replaced with the phrase "FIFTY THOUSAND PESOS (P50,000.00)";
- 12. Section 10 of the Senate version and Section 12 of the House version (Appropriations) were merged and refined to become Section 12 of the consolidated version, to read:

"SEC. 12. APPROPRIATIONS. - FOR THE IMPLEMENTATION OF THE PROVISIONS OF THIS ACT, THE AMOUNT OF FIFTY MILLION PESOS (P50,000,000.00) IS HEREBY APPROPRIATED AND SHALL BE TAKEN FROM THE ORGANIZATIONAL ADJUSTMENT FUND FOR THE ACQUISITION OF THE NECESSARY EQUIPMENT, SUPPLIES AND EXPERTISE.

THEREAFTER, THE AMOUNT NECESSARY TO CARRY OUT THE PROVISIONS OF THIS ACT SHALL BE INCLUDED IN THE GENERAL APPROPRIATIONS ACT OF THE YEAR FOLLOWING ITS ENACTMENT INTO LAW.

ANY AND ALL AMOUNTS COLLECTED BY THE PANEL IN THE EXERCISE OF ITS FUNCTIONS SHALL BERETAINED BY THE NATIONAL MUSEUM TO AUGMENT ITS ANNUAL APPROPRIATIONS. DISBURSEMENTS THEREFROM SHALL BE SUBJECT TO THE APPROVAL OF THE BOARD OF TRUSTEES OF THE NATIONAL MUSEUM.";

13. A new Section 13 was introduced, which shall read as follows:

"SECTION 13. IMPLEMENTING RULES AND REGULATIONS. - THE BOARD OF TRUSTEES OF THE NATIONAL MUSEUM SHALL PROMULGATE THE NECESSARY RULES AND REGULATIONS FOR THE EFFECTIVE IMPLEMENTATION OF THE PROVISIONS OF THIS ACT.";

14. The title of the bill shall read:

AN ACT DEFINING THE CRIME OF ART FORGERY, PROVIDING PENALTIES, AND INSTITU-TIONALIZING A MECHANISM FOR ART AUTHENTICATION, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES

In case of conflict between statements and amendments stated in this Explanatory Statement and that of the provisions of the reconciled version in the accompanying Conference Committee Report, the provisions of the latter shall prevail.
