Senator Cayetano. No, that is found in the previous page, Mr. President, the one that the Chair has amended on page 3, which is typewritten in all caps.

The President. In all caps. All right. As long as that is understood.

Senator Tatad. We now go to page 4.

The President. Page 4. [Silence]

Senator Tatad. Page 5.

The President. Page 5. [Silence]

Senator Tatad. There is none. I do not believe there is any proposal here.

May we return to page 2, Mr. President.

The President. Go back to page 2.

TATAD AMENDMENT

Senator Tatad. My attention has just been called by my staff. In the second line of page 2, the proposal is to change the word "gender" to SEX. There is a distinction between the two words. I am just made to understand a person's sex is what appears on the record—male or female. Gender is either masculine or feminine.

The President. Yes.

Senator Cayetano. Yes, we accept that, if it is an editorial or an individual amendment.

Instead of the word "gender" it will be SEX.

The President. The amendment is accepted.

Is there any objection? [Silence] There being none, the amendment is approved.

Senator Tatad. Yes. Thank you, Mr. President.

May we reflect the Senate President's omnibus amendment in the title of the bill now "CHANGE OF FIRST NAME OR NICKNAME.

Senator Cayetano. CHANGE OF FIRST NAME OR NICKNAME.

Senator Tatad. Yes, Mr. President.

The President. Yes.

Senator Tatad. There being no further individual amendments, I move that we close the period of individual amendments.

The President. Is there any objection? [Silence] There being none, the motion is approved.

APPROVAL OF S. NO. 2159 ON SECOND READING

Senator Tatad. Mr. President, I move that we vote on Second Reading on Senate Bill No. 2159, as amended.

The President. Is there any objection? [Silence] There being none, we shall now vote on Second Reading on Senate Bill No. 2159, as amended.

Senate Bill No. 2159, as amended, is approved on Second Reading.

BILL ON SECOND READING S. No. 1956 -- National Caves and Cave Resources Management and Protection Act (Continuation)

Senator Tatad. Mr. President, I move that we resume consideration of Senate Bill No. 1956, as reported out under Committee Report No. 200.

The President. Is there any objection? [Silence] There being none, resumption of consideration of Senate Bill No. 1956 is now in order.

Senator Tatad. Mr. President, this bill has been sleeping serenely in our Calendar.

There are a number of senators who have made the reservation to interpellate. I understand from the sponsor that they all have agreed to withdraw their reservation. So, we can now proceed to close the period of interpellations on Senate Bill No. 1956. I so move, Mr. President.

The President. All right. Is there any objection? [Silence] There being none, the motion is approved. Shall we recognize Senator Jaworski?

Senator Jaworski. Thank you, Mr. President.

Mr. President, if that has been carried or approved, then I would like to propose some committee amendments.

Senator Tatad. We are now ready for the committee amendments, Mr. President.

The President. Yes, committee amendments.

Senator Jaworski. Mr. President, this representation humbly submits the following committee amendments:

On page 2, line 27, under Section 4 of the bill, after the word "Museum"...

Senator Roco. Mr. President.

The President. Sen. Raul S. Roco is recognized.

COMMITTEE AMENDMENTS

Senator Jaworski. On page 2, line 27, under Section 4 of the bill, after the word "Museum", insert a comma (,) and the words THE NATIONAL HISTORICAL INSTITUTE. So that now it reads as follows:

"SEC.4. Implementing Agency." The DENR shall be the lead agency tasked to implement the provisions of this Act in coordination with the Department of Tourism (DOT), the National Museum, THE NATIONAL HISTORICAL INSTITUTE and concerned local government units (LGUs) for specific caves, except that in the Province of Palawan, the Palawan Council for Sustainable Development shall be the lead implementing agency pursuant to Republic Act No. 7611 or the Strategic Environmental Plan for Palawan Act.

Mr. President, on page 4, line 16, under Section 6 of the bill, after the word "Museum", insert the words THE NATIONAL HISTORICAL INSTITUTE, so that it will now read as follows:

SECTION 6. INFORMATION CONCERNING THE NATURE AND LOCATION OF SIGNIFICANT CAVES. - Information concerning the nature and specific location of a potentially significant cave shall not be made available to the public within one (1) year after its delivery by the DENR during which time the DENR, in coordination with the DOT, the National Museum, THENATIONAL HISTORICAL INSTITUTE, concerned LGUs, the scientific community and the academe, shall assess its archeological, cultural, ecological, historical and scientific value, unless a written request is made and the secretary determines that disclosure of such information will further the purpose of this act and will not create a substantial risk of harm, theft or destruction on such cave.

The Presiding Officer [Sen. Sotto]. Mr. Majority Leader, let us dispose of the first amendment first on page 2, line 27.

Senator Tatad. Yes, Mr. President. There being no objection, I move that the first amendment be approved.

The Presiding Officer [Sen. Sotto]. Is there any objection? [Silence] There being none, the first amendment is approved.

Then the second amendment on page 4, line 16.

Senator Tatad. I move that the second amendment be approved.

The Presiding Officer [Sen. Sotto]. Is there any objection? [Silence] There being none, the second amendment is approved.

Senator Jaworski. That is about all. Thank you, Mr. President.

Senator Tatad. There being no further individual amendments, I move that the period of individual amendments be closed.

The Presiding Officer [Sen. Sotto]. Is there any objection? [Silence] There being none, the motion is approved.

APPROVAL OF S. NO. 1956 ON SECOND READING

Senator Tatad. Mr. President, I move that we vote on Second Reading on Senate Bill No. 1956, as amended.

The Presiding Officer [Sen. Sotto]. Is there any objection? [Silence] There being none, we shall now vote on Second Reading on Senate Bill No. 1956, as amended.

As many as are in favor of the bill, say aye.

The Presiding Officer [Sen. Sotto]. As many as are against the bill, say *nay*. [Silence]

Senate Bill No. 1956, as amended, is approved on Second Reading.
