# APPROVAL OF S. NO. 2157 ON THIRD READING

The President. With 17 affirmative votes, no negative vote, and no abstention, Senate Bill No. 2157 is approved on Third Reading.

Senator Tatad. Mr. President, on a question of personal and collective privilege, I ask that I be recognized.

The President. The Majority Leader is recognized on a question of personal and collective privilege.

# QUESTION OF PRIVILEGE OF SENATOR TATAD (On the Integrity of the Rules of the Senate)

Senator Tatad. Mr. President, I rise on a question of personal and collective privilege. The reason for my rising this afternoon has to do with the integrity of our Rules of the Senate. It is a matter of the highest privilege.

In this morning's hearing of the Senate Blue Ribbon Committee, I called attention to Section 8 of our Rules of Procedure Governing Inquiries in Aid of Legislation and asked that the committee comply with it before proceeding to hear the substance of the charges made by the distinguished Senate Minority Leader on the floor of the Senate on October 5, 2000 against the President of the Philippines.

This section provides:

Sec. 8. Preliminary Determination. -- Except in cases of bills and resolutions (which do not call for an investigation or inquiry) filed for consideration, the Committee to which a speech, resolution, petition, or information has been referred by the President shall meet within five (5) days after such referral, with proper notice to all its members, in an executive meeting to determine the action it would take thereon.

A decision to conduct an inquiry shall require the concurrence of a majority of the members present provided there is a quorum.

The decision of a Committee, whether or not to conduct an inquiry, shall be reported to the Committee on Rules. The Committee on Rules shall then regularly inform the Senate of such action taken by the Committee.

My reason for presenting this motion was to enable the committee to receive whatever documents the Senate Minority Leader may wish to present to the Body to support his serious but so far undocumented charges of wrongdoing against the President of the Philippines so that we, the committee, could decide how best to proceed.

As we all know, this is the first time in our legislative history that a senior member of the Opposition has accused the President of the Republic directly and by name of having committed impeachable offenses, in an open session of the Senate.

Since the Constitution says in Article VI, Section 21 that "The Senate or the House of Representatives or any of its
