AN ACT STRENGTHENING THE GOVERNANCE AND
DEFINING THE SCOPE OF THE PHILIPPINE SCIENCE
HIGH SCHOOL (PSHS) SYSTEM, AMENDING FOR
THE PURPOSE REPUBLIC ACT NO. 8496

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. A second paragraph is hereby added under Section
2 of Republic Act No. 8496, otherwise known as the Philippine Science
3 High School (PSHS) Sytem Act of 1997, to read as follows:

4 "THE STATE SHALL ALSO ENSURE THAT EVERY
5 REGION IS GIVEN EQUAL OPPORTUNITY TO BENEFIT
6 FROM THE ESTABLISHMENT OF THE PSHS SYSTEM.
7 TOWARDS THIS END, ONLY ONE (1) PSHS CAMPUS SHALL
8 BE ESTABLISHED IN EACH OF THE ADMINISTRATIVE
9 REGIONS OF THE COUNTRY."

10 SEC. 2. Section 3, paragraph (a) of the same Act is hereby

1 amended to read as follows:

2 "(a) Integrate the existing PSHS at Diliman; NUEVA
3 VIZCAYA, CAMARINES SUR, ILOILO CITY, LEYTE, LANA
4 DEL NORTE AND DAVAO CITY [Eastern Visayas, Western
5 Visayas and Mindanao] into one system of governance and
6 management;"

7 SEC. 3. Section 5 of the same Act is hereby amended to read as
8 follows:

9 "SEC. 5. *Scope.* - The Philippine Science High School
10 System shall be composed of the existing PSHS campuses
11 HEREIN MENTIONED [at Diliman, Eastern Visayas, Western
12 Visayas and Mindanao,] and future campuses which shall be
13 established under this [law] ACT. THE EXISTING CAMPUSES
14 AT DILIMAN, QUEZON CITY; BAYOMBONG, NUEVA
15 VIZCAYA; GOA, CAMARINES SUR; JARO, ILOILO CITY;
16 PALO, LEYTE; TUGBOK, DAVAO CITY; AND BALO-I, LANA
17 DEL NORTE, SHALL BE KNOWN AS THE PSHS MAIN
18 CAMPUS, PSHS CAGAYAN VALLEY, PSHS BICOL REGION,
19 PSHS WESTERN VISAYAS, PSHS EASTERN VISAYAS, PSHS
20 SOUTHERN MINDANAO AND PSHS CENTRAL MINDANAO,
21 RESPECTIVELY.

22 THE NUEVA VISCAYA SCIENCE HIGH SCHOOL,
23 ESTABLISHED UNDER REPUBLIC ACT NO. 7622, AS
24 AMENDED BY REPUBLIC ACT NO. 8364, IS HEREBY
25 ABSORBED BY THE PSHS SYSTEM AND SHALL BECOME

1 PSHS CAGAYAN VALLEY CAMPUS.

2 THE PSHS BICOL CAMPUS LOCATED IN THE
3 MUNICIPALITY OF GOA, CAMARINES SUR, ESTABLISHED
4 UNDER REPUBLIC ACT NO. 8304, AS AMENDED BY
5 REPUBLIC ACT NO. 8619, SHALL BE CONSIDERED DISTINCT
6 AND SEPARATE FROM THE SAN RAFAEL NATIONAL HIGH
7 SCHOOL IN THE MUNICIPALITY OF TIGAON, CAMARINES
8 SUR. THE SAN RAFAEL NATIONAL HIGH SCHOOL SHALL
9 CONTINUE TO EXIST UNDER THE SUPERVISION OF THE
10 DECS PURSUANT TO THE PROVISIONS OF BATAS
11 PAMBANSA BLG. 580, AS AMENDED, AND SHALL
12 MAINTAIN ALL PERSONNEL, ASSETS, LIABILITIES AND
13 RECORDS PREVIOUSLY TRANSFERRED AND ABSORBED BY
14 THE PSHS BICOL CAMPUS.”

15 SEC. 4. A new Section 6 is hereby inserted between Sections 5
16 and 6 of the same Act, to read as follows:

17 “SEC. 6. *RESTRICTION ON THE CONVERSION OF HIGH*
18 *SCHOOLS INTO A PHILIPPINE SCIENCE HIGH SCHOOL. - IN*
19 *ADDITION TO THE GUIDELINES/CRITERIA THAT MAY BE*
20 *ESTABLISHED BY THE PSHS BOARD OF TRUSTEES IN THE*
21 *ESTABLISHMENT AND OPERATION OF SCIENCE HIGH*
22 *SCHOOL, THE CONVERSION AND INCLUSION OF EXISTING*
23 *HIGH SCHOOLS INTO THE PSHS SYSTEM SHALL NOT BE*
24 *ALLOWED.”*

1 SEC. 5. Section 6 of the same Act is hereby amended to read as
2 follows:

3 “SEC. [6] 7. *Overall Coordinating Authority. - The PSHS*
4 *System shall be under the administrative supervision of the*
5 *Department of Science and Technology (DOST). THE PSHS*
6 *SYSTEM BOARD OF TRUSTEES (BOT) SHALL BE THE*
7 *GOVERNING BOARD OF ALL THE PSHS CAMPUSES*
8 *WHEREVER SITUATED.”*

9 SEC. 6. Section 7 of the same Act is hereby amended to read as
10 follows:

11 “SEC. [7] 8. *Board of Trustees. - There shall be a Board of*
12 *Trustees composed of the secretary of the DOST as ex-officio*
13 *Chairman, the secretary of DECS as ex-officio Vice Chairman, and*
14 *the following members: The President of the U.P., the Executive*
15 *Director of PSHS, the Director of the Science Education Institute*
16 *(SEI), [and] the President from the PSHS National Alumni*
17 *Association, AND THE CHAIRPERSONS OF THE*
18 *CONGRESSIONAL COMMITTEES ON SCIENCE AND*
19 *TECHNOLOGY as ex-officio members; and one (1) representative*
20 *each from the private sector representing higher education,*
21 *education for the gifted, industry, agriculture, and new and*
22 *emerging technologies. The private sector representatives shall*
23 *be appointed by [the Chairman subject to the confirmation of]*
24 *the Board of Trustees UPON RECOMMENDATION OF A DULY*
25 *CONSTITUTED SEARCH COMMITTEE. For the first set of*

1 appointments, three (3) of them shall serve for four (4) years,
2 while the other two (2) for two (2) years, thereafter, succeeding
3 appointments shall have a fixed term of four (4) years.

4 The Board shall exercise the following powers:

5 (a) Formulate policies and guidelines for the
6 administration and operation of the PSHS System;

7 (B) ESTABLISH A PSHS CAMPUS IN EACH OF THE
8 ADMINISTRATIVE REGIONS;

9 (C) [b] [Formulate policies on the] APPROVE
10 appointment, promotion, retention, [removal,] renewal, rewards
11 and incentives for [administrators,] faculty and staff, FIX THEIR
12 COMPENSATION AND OTHER CONDITIONS OF
13 EMPLOYMENT, AND REMOVE THEM FOR CAUSE AFTER
14 PROPER INVESTIGATION AND HEARING;

15 (D)[c] Approve the curricula submitted by the Executive
16 Director;

17 (E)[d] Approve the criteria for the selection and admission
18 of students;

19 (F)[e] Approve the grant of scholarship, stipend and such
20 allowances for students;

21 (G)[f] Approve the graduation of successful candidates
22 from the various PSHS campuses;

23 (H)[g] Formulate policies and rules of discipline for
24 students, faculty and staff;

1 (I)[h] Approve the PSHS System budget, RECEIVE and
2 appropriate to the ends specified by law such sums as may be
3 provided by law for the support of the System;

4 (J)[i] Receive grants whether cash, land, buildings and
5 improvements thereof; donations, contributions, bequestS, gifts,
6 and to formulate policies for the administration thereof;

7 (K) APPROVE THE USE OF ALL INCOME GENERATED
8 BY THE SCHOOL IN THE PURSUIT OF ITS FUNCTIONS AND
9 DONATIONS RECEIVED IN TRUST BY INDIVIDUAL
10 CAMPUSES, ACCORDING TO THE PURPOSE OF THE DONOR
11 AND INTENTION OF THE DONATION. IN CASES WHERE
12 INCOME/DONATION RECEIVED IS NOT INTENDED FOR A
13 PARTICULAR CAMPUS, THE BOARD SHALL LIKEWISE
14 APPROPRIATE THE SAME FOR THE BENEFIT OF THE
15 SYSTEM OR ANY PART THEREOF;

16 (L)[j] Develop policies for the expansion of enrollment in
17 the campuses under the PSHS System;

18 (M)[k] [Set] ESTABLISH policies and FORMULATE
19 GUIDELINES/criteria, REQUIREMENTS NECESSARY to
20 rationalize the establishment AND OPERATION of the science
21 high schools under the System IN ORDER TO MAINTAIN THE
22 QUALITY AND UNIFORM STANDARD INHERENT OF A
23 BONAFIDE PSHS [, for its evaluation and approval thereof]; and

24 (N)[l] Prepare strategic plans to enhance the capability of
25 the System in developing human resources with focus on youth

with special talents in science and mathematics.”

SEC. 7. Section 8 of the same Act is hereby amended to read as follows:

“SEC. [8] 9. *Executive Director (ED)*. - There shall be an Executive Director who shall be appointed by [the Chairman, subject to the approval of] the Board and shall be conferred the rank equivalent to a bureau director with a fixed term of six (6) years, renewable for another term. The ED shall [coordinate the implementation] EXERCISE ADMINISTRATIVE SUPERVISION OVER ALL CAMPUS DIRECTORS AND SHALL BE THE PRIMARY IMPLEMENTOR of policies and guidelines set by the Board of Trustees. As a member of the Board of Trustees, the ED shall articulate to the Board the mutual concern of all the campuses.”

SEC. 8. A new Section 10 is hereby inserted between Sections 8 and 9 of the same Act, to read as follows;

“SEC. 10. *DEPUTY EXECUTIVE DIRECTOR (DED)*. - THERE SHALL BE A DEPUTY EXECUTIVE DIRECTOR (DED) WHO SHALL BE APPOINTED BY THE BOARD FOR A TERM OF SIX (6) YEARS, RENEWABLE FOR ANOTHER TERM. THE DED SHALL PERFORM THE DUTIES AND FUNCTIONS ASSIGNED BY THE EXECUTIVE DIRECTOR.”

SEC. 9. Section 9 of the same Act is hereby renumbered as Section 11.

SEC. 10. Section 10 of the same Act shall be amended, to read as follows:

“SEC. [10] 12. *Executive Committee*. - There shall be an Executive Committee IN THE PSHS SYSTEM composed of the Executive Director AS *EX-OFFICIO* CHAIRPERSON and the Campus Directors [in the PSHS System] as members. [The committee shall be collegial in character.]”

SEC. 11. Sections 11, 12, 13, 14 and 15 of the same Act are hereby renumbered accordingly.

SEC. 12. *Repealing and Amending Clause*. - All laws, executive orders, presidential decrees, rules and regulations or parts hereof which are inconsistent with any provision of this Act are hereby repealed or amended accordingly.

SEC. 13. *Effectivity*. - This Act shall take effect immediately upon its approval.
