fererees Congressmen Yap (J), Unico, Padilla, Rivera,
Jr., Lingad, Isidro and Ablan on August 13, 1990;

Senate accepted the request of the House of Representatives
for a conference on the disagreeing provisions of
S. No. 88 and H. B. No. 12251, designating as its
confererees Senators Guingona, Jr., Maceda, Tamano,
Pimentel, Jr. and Enrile on September 6, 1990;

Conference Committee recommended that H. B. No. 12251 and
S. No. 88 be consolidated and approved;

Conference Committee Report agreed to by the Senate on
March 19, 1991;

Conference Committee Report agreed to by the House of
Representatives on April 22, 1991;

Consolidated with H. B. No. 12251 which was approved and
signed by the President of the Philippines on
June 27, 1991 and denominated as Republic Act
No. 7077.
