AN ACT PROVIDING FOR THE REPATRIATION OF FILIPINO WOMEN WHO HAVE LOST THEIR PHILIPPINE CITIZENSHIP BY MARRIAGE TO ALIENS AND OF NATURAL-BORN FILIPINOS.

The following is the full text of House Bill No. 1248:

AN ACT PROVIDING FOR THE REPATRIATION OF FILIPINO WOMEN WHO HAVE LOST THEIR PHILIPPINE CITIZENSHIP BY MARRIAGE TO ALIENS AND OF NATURAL-BORN FILIPINOS

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Filipino women who have lost their Philippine citizenship by marriage to aliens and naturalborn Filipinos who have lost their Philippine citizenship, including their minor children, on account of political or economic necessity, may reacquire Philippine citizenship through repatriation in the manner provided in Section 4 of Commonwealth Act No. 63, as amended: *Provided, That* the applicant is not a:

(1) Person opposed to organized government or affiliated with any association or group of persons who uphold and teach doctrines opposing organized government;

(2) Person defending or teaching the necessity or propriety of violence, personal assault, or association for the predominance of their ideas;

(3) Person convicted of crimes involving moral turpitude; or

(4) Person suffering from mental alienation or incurable contagious diseases.

SEC. 2. Repatriation shall be effected by taking the necessary oath of allegiance to the Republic of the Philippines and registration in the proper civil registry and in the Bureau of Immigration. The Bureau of Immigration shall thereupon cancel the pertinent alien certificate of registration and issue the certificate of identification as Filipino citizen to the repatriated citizen.

SEC. 3. All laws, decrees, orders, rules and regulations, or parts thereof inconsistent with this Act are hereby repealed or amended accordingly.

SEC. 4. This Act shall take effect thirty (30) days after its publication in a newspaper of general circulation.

Senator Romulo: Mr. President, for the sponsorship remarks, I ask that the Chairman of the Committee on Justice and Human Rights, Senator Roco, be recognized.

The Presiding Officer [Senator Lina]: Senator Roco is recognized.

SPONSORSHIP SPEECH OF SENATOR ROCO

Senator Roco: Mr. President, on behalf of the Committee on Justice and Human Rights, may we just correct and add to the Report that a similar bill has been filed by Senator Tatad, and that by omission, he was not put here. So the bill of Senator Tatad is being included in the Report.

The Report seeks the approval of the Chamber for House Bill No. 1248, "An Act Providing for the Repatriation of Filipino Women who have lost their Philippine Citizenship by Marriage to Alien and Natural-Born Filipinos."

In the interest of time, we will ask that my Sponsorship Speech, composed of three pages, single-spaced, be inserted into the *Record*. But I will just touch on the highlights.

This bill has been reported out by the Committee, and it is one of the rare Reports where there is no reservation and no proposed amendments. The Committee and all the Members of the Committee, even the *ex officio* Members, have signed in favor, except for Senator Shahani, the President Pro Tempore, only because we were not able to catch her at the time of the signing, and the Senate President who, as a matter of practice, has not been signing the Report.

The need to act on this bill emanated from an interpellation of Senator Herrera when we were discussing the legalization of residence. There was an effort by Senator Herrera to include repatriation because, as he pointed out, first, it seems unfair that we are liberalizing legalization of residence, but the problem of Filipino women and other natural-born Filipinos who have lost their citizenship by marriage or other causes and for other reasons are not being addressed. That is why we thought it should be reported accordingly.

Second, we also want to give an opportunity to all our compatriots who are abroad to be able to come home in an easier manner. Under the present procedures to reacquire citizenship for Filipino women, the procedures are very cumbersome. There must be a petition filed before the Regional Trial Court, and they must have their marriages dissolved. So it becomes almost prohibitive, one has to go through the eye of the needle to get her citizenship back.

A third reason is, we want to reintegrate into the mainstream of Filipino life those who may have temporarily lost their Filipino citizenship. As we know, there are more Filipino doctors in the U.S. than there are in the Philippines.

The list of Filipino doctors or former Filipinos who are practicing medicine in the United States is twice as many as the Filipino doctors who are still here. Because of certain provisions of law where we favor restricting the practice of the profession to Filipinos, some of our doctors abroad are hesitant to come back and work for their repatriation. This bill will address and simplify that problem.

The bill is fairly simple. Those who have lost their citizenship in one way or the other — and this may include the veterans in due course, although this is covered by a separate report — shall take the necessary oath of allegiance to the Republic of the Philippines and register in the proper civil registry and in the Bureau of Immigration. The Bureau of Immigration shall thereupon cancel the pertinent Alien Certificate of Registration and issue the certificate of identification as Filipino citizen to the repatriated citizen. It becomes fairly straightforward, Mr. President, and simplifies procedures for reacquiring lost citizenship.

Those are the reasons that have prompted the Committee, Mr. President, to seek the unanimous support of the Chamber.

Senator Romulo: We have no objection, Mr. President.
